Judge McQueen Sentences Eight **Tuesday Morning** 

Judge W. B. McQueen sentenced eight culprits at the regular session of recorder's court Tuesday. Oscar Fairley, negro from Scotland county, pled guilty to being drunk and disorderly and was sentenced to thirty days on the roads, sentence to be suspended on payment of the court. costs. He paid out and was released.

Oscar Bandy, Blue Springs negro, pled not guilty to charges of assault with a deadly weapon and carrying a concealed weapon. Judge McQueen decided against the defendant, however, and sentenced him to ninety days on the roads on the latter count, sentence to be suspended on payment of \$50 and the costs. He sentenced him to sixty days on the other charge, sentence to be suspended on payment of the costs and a fine of \$10. Bandy chose to go to the roads.

Went Haynes, Antioch negro, was found guilty of assault with a deadly weapon and was released after payment of the costs and a fine of \$10.

Walter Locklear and Wingate Mc-Millan, Indian citizens from Allendale township, were found guilty of violating the prohibition law on two charges and received sentences of six months on the roads in each instance, the sentences to run concurrently. The first charge was possession of homemade beer for sale and the second charge was making wiskey. Both defendants chose to go to the roads instead of paying each, which were posted. out.



In a release received yesterday from the office of government reports it was learned that a total of \$3,089,176.35 on National Defense Awards and Contracts has been awarded in North Carolina between June 13, 1940 and July 31, 1940.

The release for July includes a series of awards given for the Army totaling \$641,578.65, and for the funds from the Works Progress Administration for the construction of utilities and roads for the Army at Fort Bragg of \$250,000.00, making a total of awards in North Carolina for the period July 12-31, 1940, of \$959,566.65.

In the July awards for the Army, eleased through the Quartermaster Corps, Holmes Electric Company of Fayetteville received a contract of \$1,735 for light installations at Fort Bragg; Chatham Manufacturing Co. of Elkin received a contract of \$449,-250 for wool blankets, o. d.; Cramerton Mills of Cramerton received a contract of \$190,593.65 for cotton cloth.

For the Navy the Thomas Mills of High Point received a contract of \$21,528 for socks; V. P. Loftis Company of Charlotte received a contract of \$44,835 for Hospital Building, Naval Hospital, Charleston, S. C.; Lily Mills Company of Shelby re-\$1,625 worth of cotton thread.





S. L. Akins, former citizen of Hoke county, passed away at his home in Asheboro last Sunday morning at two o'clock. Funeral services were conducted at the home Monday afternoon at two o'clock. Interment followed in the cemetery here. Graveside service was conducted by Rev. W. F. Trawick, former pastor of the Raeford Methodist church.

Surviving are four daughters, Miss Lillian Akins, Mrs. Paul Binchfield, Mrs. Garrett Cox, all of Asheboro, and Mrs. J. C. Poole of Thomasville, Navy, \$67,988.00. It also includes a son Albert Akins of Asheboro; two brothers, N. R. Akins of Gibsonville, and W. M. Akins of Franklinville.



Mrs. Effie Meacham McCartha, wife of Carl W. McCartha, principal of Gastonia Junior high school, and sister of H. L. Meacham, State Agriculturist for the Barrett Company and former Hoke County Farm Agent, was instantly killed about 4:45 o'clock last Friday afternoon when the brakes of a coal truck which had just delivered a load of fuel to her home gave way and the truck crushed her against the side of the

house.

The driver had finished putting the load of coal into the basement and had driven the truck up the rather steep drive and stopped it with the brakes on to go back and get Mrs. McCartha to sign for the load of coal. Mrs. McCartha had come out of the basement door to sign the ticket and she and the Negro were standing next to the house when the brakes of the truck apparently gave way and the heavy vehicle crushed Mrs. McCartha against the brick walls of the house.

Without delay, the Red Cross dispatched nurses to the stricken area to begin precautionary immunization against disease and otherwise minister to sufferers. The Works Progress administration sent Assistant Commissioner Fred R. Rauch from Washington to assist in emergency work.

Beaufort, south of Charleston, apparently was hardest hit by the 80mile an hour gale that swept out of the Bahamas Sunday, wrecking watides into city streets and homes. The Red Cross reported from washington that 25 Negroes were killed on Saint Helena island near Beaufort. Eight other negroes died on nearby Ladies' island. Reports from these outlying islands were described as incomplete, and fear was

expressed that the death toll would be higher. A CCC boy was drowned on Hunt-

ngton island, near here, and two persons perished in Savannah, Ga.

Raleigh, Aug. 10 .- The first statewide census figures, released here work today to dig out of the wreck- today by Census Area Manager E A. Hughes, showed that the population of North Carolina increased millions of dollars and left hundreds 391,714 in the last decade to a total of 3,561,990.

The increase will virtually assure North Carolina of an additional member of the United States House of Representatives, giving the state a total of 12 representatives.

The report, subject to minor corrections, showed Charlotte again as the state's largest city, and the first to exceed the 100,000 mark, its total being 101,305. (This figure was a gain of nearly 1,000 over an earlier esimate which put Charlotte's population at 100,327.) The Mecklenterfront buildings and sending high burg county seat has grown rapidly since 1900, when it was credited with only 18,091 inhabitants.

The figures also revealed the continued growth of the Piedmont industrial region.

The second largest city in the state is Winston-Salem, with 79,828 resident. Durham is third, Greensboro fourth, Asheville fifth, Raleigh sixth, High Point seventh, and Wilmington eighth.

#### National Guard Unit To Increase Strength

Columbia, S. C., Aug. 13 .- The 30th division of the national guard, scheduled to be mobilized at Camp Jackson for active service, will be increased to a strength of 14,341 officers and men, an advice received today by Adjutant General James C. Dozier disclosed.

Authorization for recruiting which would bring the total personnel up to "peace-time" strength has been granted, meaning an increase of slightly more than 2,000 officers and men. The division has units in the Carolinas, Georgia, and Tennessee.
