We recommend the use of BHC (3 per cent BenzineHexaChloride, 5per cent DDT) as a dust applied at 6 to 10 pounds per acre. Any good duster, Hand or tractor operated, will do the job, or you may secure the help of Mr. Clyde Christopher to dust by airplane at \$1.00 per acre. He may be contacted at the local airport.

Should you desire our help in securing the above poison materials we will be glad to secure them for you at cost if possible.

If you don't make cotton we will miss your seed.
