### HOKE GIRL AMONG 612 MEREDITH STUDENTS

Raleigh, N. C., October 2.—The estimated 600 students which Meredith College officials predicted for the 1950-51 semester just beginning has proven to be exactly 612, including regular and special (part-time) students, according to official figures released by Mrs. Vera Tart Marsh, College Registrar. This is an increase of 56 over the 556 students enrolled in 1949-50.

The student body represents 74 North Carolina counties, 13 other states and the District of Columbia, and six foreign countries and territories outside continental United States, including China, Cuba, Costa Rica, Puerto Rico, and Palestine.
