United Fund Campaign Hopes To Net \$22,000 **Two-Week** Canvass **Is Planned**

Raeford-Hoke United Fund will launch its annual fund-raising campaign here Monday, and fund officials said they hope the drive can be completed this year in the two-week campaign period, which will end November 3.

Goal in this year's drive is \$22,027.75 -- only slightly higher than last year's goal, which was surpassed. Only twice in the 14-year history of the drive has the campaign ended up short of its goal.

Chairman of this year's campaign is Palmer Willcox, local attorney and member of the Raeford town board. Vice chairman is Bobby Conoly, banker.

Volunteer workers will canvass the residential areas of the town and county. Downtown business and professional men will solicit contributions from their employes. Industrial plants will conduct the drive within their plants.





Raeford Firemen Winners Williams **Is Director Of Five-Way Competition**

Volunteer fire departments County communities staged an afternoon of fun and competition here last Wednesday in observance of National Fire Pre-

vention Week. The Raeford department was adjudged winner of the competition and received a bronze plaque. Puppy Creek was second.

The competition was sponsored by Raeford-Hoke Chamber of Commerce to attract attention to the volunteer firefighting units in Raeford and the county. Competing were the departments from Raeford, North Raeford, Rockfish, Puppy Creek and Hillcrest. A sixth department, Stonewall, did not compete because most of its volunteer firemen are farmers and were working on Wednesday afternoon.

Four events were staged, with all but one being judged on time. They were ladder rescue from the second floor of town hall; filling a 55-gallon barrel with water from the department's pumpers: dousing an oll fire, and rolling a barrel with water. while an opposing team applied resistance. The last event did not count in the scoring.

Raeford's wirning time, an average of the three events, was 50.6 seconds. In second place was Puppy Creek with 55.4 seconds, Hillcrest was close behind with 56.4 seconds; Rockfish, which was disquali-10 o's rur, had 64.2 fied seconds, and North Raeford, also disqualified in or e attempt, had an average of 65.6.

State Highway Patrolman K. K. Daniels of Cumberland County said the charges have been filed against Robert Spencer, Raeford Rt. 2.

Spencer was arrested Saturday afternoon at the home of William Hart Jr., Fayetteville Rt. 8. Both Spencer and Hart were jailed in lieu of \$20,000 bond. Hart was charged with being an accessory after the fact.
