A.W. Wood III To Represent N.C. In Senate Youth Program

Sam J. Ervin, Jr. have announced that, Allen Wilton Wood and Frederick Marshall Casey were named by State Superintendent of Public Instruction Craig Phillips to represent the State of North Carolina in the 1970 United States Senate Youth Program. Each delegate will receive a \$1,000 college scholarship made possible by a grant from the William Randolph Hearst Foundation. Allen Wilton Wood of Raeford, attends

Hoke County High School. Wood is president of the student council, editor of the school yearbook, a member of the beta club, and a member of the Bucks football team.

Frederick Marshall Casey Waynesville, attends Tuscola High School, He is treasurer of the senior class, a member of the key club, and a student council representative.

Since its inception in 1962, the U.S. Senate Youth Program has brought 714 high school student body officers to observe the proceedings on Capitol Hill. This year 102 more students will have the opportunity to take part in the week-long internship program, which will be held in Washington, D.C. from January 24 to 31, 1970.

Operations of the Senate will be stressed during the week, and the delegates will visit the offices of their respective Senators.

It is anticipated that the President and Vice President will again meet with the delegates, as they have in past years, and briefings with leading Cabinet members. Senators, military officers and a Supreme Court Justice are also scheduled.
