

# Court Convicts Hollingsworth; Gives Six Month Sentence

George Hollingsworth, well known "club owner" in Raeford and his wife, Bertha, were found guilty on charges of interfering with a police officer in the performance of his duty, resisting arrest and assault in Friday's session of Hoke County District Court.

Hollingsworth was convicted of assault and resisting arrest, while his wife was guilty of assault and interfering with a police officer.

Judge J.E. Dupree, a former law enforcement officer himself, sentenced Hollingsworth to six months imprisonment in the Hoke County Jail, assigned to work under the supervision of the North Carolina Department of Corrections.

Bertha Hollingsworth was sentenced to six months in the quarters provided for women by the North Carolina Department of Corrections, capias and or commitment to issue at any time during the next three years on the motion of the solicitor or the court. She was also ordered to pay the costs of court.

Hollingsworth gave notice of appeal to Hoke County Superior Court. Dupree set appeal bond at \$1,000.

James Earl Locklear, Route 2, Red Springs, was found guilty of resisting arrest, sentenced to six months imprisonment in the Hoke County Jail, assigned to work under the supervision of the North Carolina Department of Corrections. Locklear gave notice of appeal and bond was set at \$1,000.

Thomas Warren Tate, Raeford, assault, the State took a nol pros with leave upon payment of the costs of court.

James Robert West, Raeford, was found innocent of assault charges.

Lola Reynolds Thompson, Route 1, Raeford, driving under the influence and improper passing, the State took a nol pros.

Allen Scott, Shannon, driving under the influence (third conviction) six months in the Hoke County Jail.

assigned to work under the supervision of the North Carolina Department of Corrections. Scott appealed the sentence, but later withdrew his appeal and accepted the judgment.

Paul Hamilton Rogers, Ft. Bragg, speeding 75/60, fined \$15 and the costs of court.

Lillie Mae Purcell, Route 3, Red Springs, was found not guilty of assault with a deadly weapon.

Billy E. McLawhorn, Raeford, assault, 30 days in the county jail, capias and or commitment to issue anytime during the next three years on the motion of the Prosecutor or the court. This sentence is to begin at the expiration of the sentence imposed in the above case. The defendant was ordered to pay \$25 for the use and benefit of the prosecuting witness and the costs of court.

James Earl Locklear, Route 2, Red Springs, assault by pointing a rifle, not-guilty. The court found frivolous and malicious prosecution on the part of the prosecuting witness. Beatrice Locklear, and ordered her to pay the costs of court. For good cause shown, the cost was remitted.

John McNeill, Route 3, Raeford, assault with a deadly weapon with intent to kill, preliminary hearing was waived by the defendant and he was bound over to the Hoke County Superior Court for action by the Grand Jury. Superior Court bond was set at \$1,000.

Henry Junior McPhatter, McCain, no operator's license, no liability insurance, and improper registration, six months, suspended for two years, two years probation, said sentence is suspended upon payment of a \$100 fine and the costs of court. For failure to comply with this sentence, the court ordered the sentence activated.

Wade McMillian, Route 1, Aberdeen, improper equipment, costs of court.

John M. McNeill, Raeford, public drunk, five days in the county jail \$5 fine and the costs of court.

Billy Locklear, Route 1, Wagram, trespass, the State took a nol pros with leave.

John M. McNeill, Raeford, public drunk (second offense), the court ordered the defendant be committed to the custody of the Commissioner of Correction for an indeterminate sentence of not

less than 30 days and not more than six months, capias and or commitment to issue at anytime during the next 12 months on motion of the solicitor or the court.

Sentence suspended for three years, three years probation, on condition that each pay \$15.55 to Cape Fear Valley Hospital on the medical bills of Lillie Mae Purcell, \$50 fine and the costs of court.

Jimmy McNair, Parkton, not guilty of a worthless check charge.

Frank Bristow, Hoke County, carrying a concealed weapon, six months in the county jail, suspended for three years. Defendant is not to carry concealed, any type weapon, including a pen knife, pay a fine of \$50 and the costs of court.

Carolyn Dunn, Route 3, Red Springs, not guilty of trespassing.

James Lonnie Crowley, Route 2, Raeford, not guilty of driving under the influence. Careless and reckless driving, six months in the county jail with capias and or commitment to issue at anytime during the next two years upon motion of the solicitor or the court. Pay a fine of \$100 and the costs of court.

Norman Billy Graham, Raeford, driving under the influence and without a valid chauffeur's or operator's license, six months in the county jail, suspended for 18 months, 18 months probation, sentence suspended on condition that defendant not operate a motor vehicle in North Carolina for 18 months, unless properly licensed to do so. 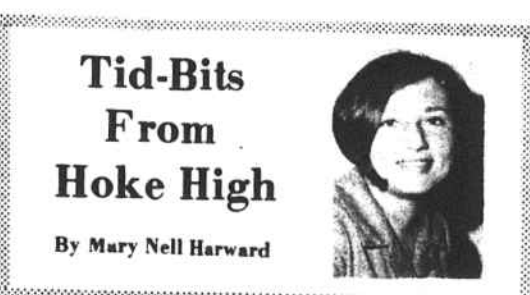
The airman, a 1965 graduate of Pinehurst High School, attended East Carolina University, Greenville, and Pembroke State College.
