#### Social Security News

I've been harping in these columns to call Fayetteville to file your claim for Social Security benefits!

To this you might well reply that that is fine, but I have to make a long distance call to Fayetteville from where I live. and this will cost me money. Also, since I understand it might take from 15 to 45 minutes to file my claim via the telephone, this could really run my phone bill up.


I am sorry if I have confused anyone regarding a teleclaim, as we call it. There are several ways we can overcome anyone wishing to file his claim by phone from running up his phone bill.

First, all you need do is phone us in Favetteville at 483-2661, and let the person you speak to know that you are interested in filing a claim for social security benefits That person will get your name and phone number and have one of our claims representatives call you back All of this shouldn't take more than the initial three minutes allowed for a long distance call and the charge should not be more than 45 cents

Second, if you want to save the 45 cents involved in a long distance call, you can drop us a line or mail us a post card asking to have your claim filed phone. Include your name and teicphone number, and we will call you.

At this point, you may well be wondering that all of these long distance calls are going to cost the Social Security Administration a lot of money This is not so, as the Social Security Administration makes of the Federal Tele communications which is a leased phone system for which there is a flat monthly charge not based upon the total number of long distance calls made
