A note from Raz Autry principal at Hoke County High School is as follows: "Once again I wish to express my appreciation for the support that you and The News — Journal render to the high school throughout theyear, and especially school throughout the year, and especially during our athletic season."

Harry Harrison, former Hoke attorney, now working for the Employment Security Commission, recently spent several days in Germany with a study group. He was one of 22 North Carolinians to make the trip.
Here are a few comments made by Harry about the trip:
"We went as a succession."

"We went as guests of the West German Republic, specifically invited for briefs on the Federal Republic of

Germany.

The Federal Parliament (Bundestag) is located in Bonn, Germany, and is the embodiment of the Federal principal. Lodging was arranged by Dr. Hans Indarf. Director of the ECU - European Study Center, 53 Bonn, Bad Godisberg at the Steigenberger Hatel

Steigenberger Hotel.
"Two particular points of interest were an 'All American' lunch at Hans Steineck, an All American lunch at Hans Steineck, ECU - European Study Center and a visit to Hotel Petersberg, possible site of a UNC branch in Europe. "W. Germany has '0' unemployment,

"W. Germany has '0' unemployment, in fact, they import 2½ million workers from neighboring countries. They do have an employment security program to which the employer contributes 50% and the worker 50%. Its primary use, however, is for seasonal unemployment. "We were invited to the Federal Parliament, Building to observe returns."

Parliament Building to observe returns. Voting is, by law, always held on Sunday The present government under Federal Chancellor Willy Brandt, a coalition of S.P.D. and F.D.P. (political parties) were returned to power and the candidate from C.D.U. conceded about 7:30 p.m., only 1½ hours after the polls closed Sunday afternoon. There was almost 90%

participation of the party memberships.

"Finally, it would amuse some of our brethren to know that we saw, a Protestant Lutheran Church constructed. near Mainz sometime after the reformation, wherein a bar was constructed in the entrance hall so that mixed drinks - or straight whiskey could be purchased in the vestibule where outer garments are left during services. The bar is open 15 minutes before services, during services, and 15 minutes afterward. Our guide and interpreter explained that the bar was instituted in the beginning to serve brandy to members who had traveled long distances in the cold weather. The practice was continued when it proved profitable to the church treasury.

The board received the report of an advisory committee which has been working for several months on a suggested policy to implement the new laws providing for orderly dismissal of



City Council Votes Yes On Rezoning

The Raeford City Council approved a rezoning recommendation of planning board at its regular monthly meeting Monday night.

The property on Harris Ave. between Bethel Road and Roberts St. belonging to Mrs. Mary Tapp and Mrs. Sarah Cubreth will be rezoned from residential to commercial.

The council voted to continue water drilling in the Turnpike Road area and discussed the proposal to be presented by Federal Cablevision at the January meeting.

Also approved subject to approval of the North Carolina Local Government Commission was a contract with A.K. Lovin and Co. for conversion of city accounting records to comply with the uniform local government accounting

The councilmen approved entering into an agreement with the North Carolina Department of Natural and Economic Resources to provide planning assistance to the city and review zoning ordinances.

At the regular meeting of the Hoke County Board of County Commissioners Monday Tax Collector Brian H.
Thornburg formally tendered his
resignation in a letter dated in mid
November and effective Dec. 1.
The letter, delivered to the board by
Thornburg, said he could no longer serve
as tax collector for personal reasons.

After presenting the letter, Thornburg

After presenting the letter Thornburg told the commissioners they had given him "a raw deal." The former tax collector said there were stories circulating about him and the board never had allowed him to present his side No Cooperation

Thornburg also stated he had been tax collector four years and had received no cooperation from anyone during that

T.C. Jones, board chairman, thanked Thornburg for his services and said the board appreciated all he had done to bring the collections up to date.

The tax collector's report for the year through November indicated 31,84 percent of taxes have been collected this year as compared wih 27.82 percent last year at the same time. Two Promotions

During the discussion it was pointed out a savings of \$7,000 a year would

out a savings of \$7,000 a year would accrue to taxpayers by operating the tax office with two people instead of three. Thornburg's salary was \$7,385.

The two who will operate the tax office were sworn in earlier Monday morning. They are former assistant tax collector, now promoted to tax collector. collector, now promoted to tax collector Elizabeth Livingston with an annual salary of \$7,385. Her former salary was \$6,541.

The second person in the office is former clerk now promoted to assistant tax collector Bonnie A. Niven with an annual salary of \$5,251,00. Mrs. Niven's former salary was \$4,051.
