RALEIGH - Tobacco officials from USDA and the industry will speak at Stabilization's 28th Annual Membership Meeting, according to Carl T. Hicks, cooperative president. The meeting is at the Memorial Auditorium in Raleigh 10 am May 21

a.m. May 31.

Hicks points out the board of directors amended the by-laws to set annual sessions 30 days earlier than past sessions to avoid the peak period when growers are extremely busy with tobacco harvesting and curing.

In order to give growers a broader preview of proposed changes in marketing the 1974 crop, the format for this year's meeting is also changed from previous years by scheduling additional

tobacco officials to speak to the group.
Hicks states William L. Lanier,
USDA-ASCS Tobacco and Peanut
Division director; W.E. Michaels, Dibrell Brothers senior vice president, and TobaccoAssociation of U.S. president; and Albert H. Graves, USDA Industrial Engineer, will participate in the annual session program. Topics will include the grower designation plan, the future of tobacco marketing, market demand and price patterns for the 1974 crop, and plans to implement a mechanized auction system at one market location for the 1974 season.

Also, President Hicks and General Manager Fred G. Bond will give their annual reports. Following adjournment at noon, a complimentary barbecue lunch will be served to all in attendance.



#### **Veterans Corner**

EDITOR'S NOTE: Veterans and their EDITOR'S NOTE: Veterans and their families are asking thousands of questions concerning the benefits their Government provides for them through the Veterans Administration. Below are some representative queries. Additional information may be obtained at any VA

Q - I am a disabled veteran. My wheelchair, provided by the Veterans Administration, does not permit me to participate in some sports events. Can I have my chair modified at VA expense?

A -- A "sports-model" wheelchair is available from the VA when it is medically prescribed and the veteran's sports activity warrants the wheelchair for his physical rehabilitation.

Q - I'm planning to be married next month. I have selected a house to buy. Does it make any difference if I apply for a Veterans Administration GI home loan before I am married?

A -- VA now accords full recognition to income and expenses of both veteran and spouse in determining ability to repay loan obligations. Formerly, local rules sometimes had the effect of discounting the spouse's income.

-- My father was discharged last year from the Army and died last month of a service - connected cause. I'm planning to enter college this fall.

Can the Veterans Administration help?
A -- Yes. VA will provide training benefits for you under its Dependents' Education Assistance program.
