Public safety, which includes the rescue squad, national guard and e ambulance service remains the same as last year, \$17,600.

The jail fund request was up slightly from \$24,080 last year to \$24,265 this year.

The fire fund, which included the county's part of the state forest ranger program, was increased from \$22,810 to \$24,257.

Garbage Pickup

Budgeted for county garbage pickup this year is \$77,368. This included \$4,368 for repainting and repair on the containers and a small reduction in the landfill operation to \$21,000. Collection costs are planned to run about \$48,000 a year.

The health department requests jumped from \$114,494 last year to \$148,945 this year, but Lester said part of the increase will be returned to the county. Child care costs of \$26,179 will be returned as will bottle tax funds, he said.

"The money is not really coming out of the taxpayer's pockets,"

The budget requests for the medical examiner remains at \$3,700.

Money Returned
The social services budget of \$1,299,929 included \$202,892 of

This is reflected by a budget request of \$373,307, but much of this is

returned to the county by the state and federal governments. Lester estimated that \$179,000 of administrative costs would be returned as well as 50 per cent of matching programs such as foster care.

The civil preparedness budget of \$20,333 includes funds for repair of the county generator this year. Last year, \$18,917 was budgeted for

Requests for the extension service dropped this year from \$30,057 to \$27,615. This was due mainly to a \$5,000 reduction in rent which will come when the extension offices move to the new county office building in September.

The veterans service request of \$12,128 reflects salary increases from last year's total of \$11,587.

Recreation Increased

A sharp jump in the recreation budget from \$21,307 last year to \$38,215 provides for plans now under discussion to hire a recreation director or purchase additional land near the Robbins Heights park.

Admission to the Sandhills regional library system upped the county library request from \$15,000 last year to \$17,500 this year. Lester said, however, that the library should gain many benefits through the regional association.

The county cost of soil mapping was included in the \$4,325 request for the Soil Conservation Service.

County development, which includes the chamber of commerce, Sandhills Development Association, \$125 to Farmer's Home Administration and senior citizens, is estimated at \$9,175.

Lester had not completed estimates for the non-departmental account, which includes employe benefits. However, he said, if salary increases are approved, the costs of social security, FICA and group insurance will increase sharply.

Contingencies

The contingency fund remains at \$30,000 needed, Lester said, if the county is to participate in federal programs.

"If you're going to take advantage of these federal programs that come up, you need a pretty good contingency fund to match with, Lester said. However, no more than five per cent of the general fund can be designated as for contingencies, he said.

The jury commission, which meets every two years, is meeting this fall, so \$1,000 is recommended in the budget requests. Only \$200 was allotted last year.

A federal program, CETA, which may be awarded to the county, is budgeted at \$30,000 and public service employment program is allocated \$70,420. These funds will be returned, however, to the

School Requests Drop

The school system request dropped this year from \$712,084.20 in county tax funds last year to \$652,973.75 this year.

This is based on \$480,261.60 requested for current expenses: \$96,100 for capital outlay and approximately \$106,712.15 for debt service.

The school bonds will account for about \$30,000 of the debt service money, Lester estimated.

The total school budget, including state and federal money, is \$2,108,929.30, school superintendent Raz Autry said. Included in this amount is a \$242,000 ESAA grant, which school officials say they doubt will be approved.

Autry said that about 15 teaching positions in the county financed

with ESAA funds will probably have to be eliminated.

At one time, 22 ESAA teachers were employed, Autry said, but that

number has dwindled due to retirement and vacancies left unfilled. Autry did not recommend any salary raises for school employees.

Lester said he did not know if the salary increases he had recommended would be approved, but felt that they were justified.

While the total was up from last year. Lester called the overall budget

# **Autry Gets Text Of Order**

The text of the court order to look into racial imbalance in Hoke Schools was received by school superintendent Raz Autry, Monday from Sen, Jesse

According to Autry, Hoke was included in the order because one school, West Hoke, deviated more than 20 per cent from the racial makeup of the county as a whole.
"As I understand it, if we explain the

reasons for the imbalance, it will be

okay," Autry said.

Autry said there was no way to correct the racial makeup at West Hoke, where black students predominate, without upsetting the ratio in another part of the county.
"The only thing we could do would

the only thing we could do would be to bus white students in up there and that would throw us out of line somewhere else," he said.

## This Is The Law

STATUTE OF LIMITATIONS

What is the statute of limitations? The statute of limitations is a statute limiting the time within which a suit may be brought. The statute operates as a bar to legal actions after the expiration of a specified time.

The periods of limitation prescribed for the various causes of action differ in the several states. The statements found in this column are those applicable to

North Carolina. The point to be remembered by a layman is that he should consult an attorney just as soon as he starts thinking about a court action. If he delays beyond the statutory period, he will find that his attorney cannot assist him. His attorney will inform him as to the latest date on which he can make up his mind about bringing the particular

Laymen should not be hesitant in consulting attorneys. They retain in strict confidence information about the personal affairs of their clients.

Within what period of time must an

contract involving a sale of personal

Under the Uniform Commercial Code, which became effective in North Carolina on July 1, 1967, the legal proceeding must be commenced within four years after the cause of action has

For contractual agreements other than those involving breach of contracts of sales of personal property, the three-year period of the statute of limitations is applicable to oral contracts and written contracts without a seal.

Where a promissory note or other debt is payable at a future date, the statute does not begin to run until the obligation becomes payable. For example, if Jones borrows money from Smith on January 1, 1970, and promises to repay on July 1, 1975, the statute of limitations begins to run on July 1, 1975. If Jones has written the word beside his name, or the word "seal" is already typed or printed on the contract at the place where he affixes his signature, Smith can wait until June 1985, to start a suit against Jones. But if the contract is oral or is an "unsealed" written contract, Smith must commence his legal proceeding not later than June 30, 1978.

If the legal proceedings are commenced within the designated time, no lapse of time afterwards will operate as a bar to the action. The statute does not require that the action be prosecuted to finality within the stated
