GUBERNATORIAL - If the State primary were not in the process of being moved back, we would have less than a year to go before the 1976 primaries - Democratic and Republican . Lt. Gov. Jim Hunt is still regarded

as way out front in Democratic speculation, with others traveling about the state feeling out sentiment for possible support. Former House Speaker Jim Ramsey of Roxboro and former, State Page Ed. O'Uperso and former. former State Rep. Ed O'Herron of Charlotte are said to be constantly on the go over the state speaking to civic

clubs and meeting with friends. HOUSE SPEAKER -Speaker Jim Green of Bladen county is regarded as a likely candidate for state-wide office next year. Whether his final decision will be for governor, lieut, governor or some other state-wide office is not known. One time talk was that Green might try to succeed himself as House Speaker - something that has not been done since the turn of the century, although there is no law against it.

With the present House membership reports are that Rep. Carl Stewart of Gaston County seems to have a solid lead over Rep. William T. (Billy) Watkins of Granville County. Of course all members of the House and Senate will be up for renomination in 1976 and the situation could change following next year's elections.

ISSUES — Thus far none of the would - be - candidates for governor have raised a real controversal issue that might stir the people. For anyone to have much of a chance to upset Hunt's apple - cart for the Democratic gubernatorial nomination, it would now appear that he would have to open up some live and controversial issues that would set people against issues that would set people against him as well as for him. That was the way the late W. Kerr Scott won over Charlie Johnson back in 1948.

Johnson was way out in the lead and it appeared that nobody could defeat him for the nomination. Kerr Scott, then commissioner of agriculture, announced his candidacy for governor and started raising issues that caught the imagination and interest of the people.

One issue which had much to do with Scott's success was where Johnson, then State Treasurer, had the State's money deposited, without drawing any interest for the State. Scott had sheets printed showing in which banks the the State's money was deposited. The bank people where the State's money was deposited in the main worked for Johnson and in the many banks where there were no State deposits, in general they worked for Scott. This issue stirred the concern of the people. Farmers carried the Scott sheets in their pockets showing where the State money was deposited. Scott called Johnson the "machine" candidate which also stirred the people. Scott's ability to raise issues which caught the imagination of the people enabled him to win over Johnson who was the initial leading candidate. the people. Farmers carried the Scott

PRIMARIES - The suggestion that holding the State primaries in August rather than May will lessen the financial burden on the candidates may not hold much water. It may stretch out the primary longer, besides the fall money - spending campaign at present seldom starts before Labor
