

The woman was taken to the Red Springs police department where Hoke county authorities were notified. She was transported to Moore Memorial Hospital in Pinehurst and refused an examination, Young said, and Deputy George McGuire transported her to Cape Fear Valley Hospital in Fayetteville where she was examined and treated.

No arrests have been made and an investigation is continuing.

The project was included on the program last summer but was not funded. Harris said he hoped that before the close of this administration that the project will be far enough along to insure that it won't be cancelled.


"It is a priority project," Harris said. "I think we owe it to the citizens, from a point of view of the traffic and the death rate on that road."
