A young Lumberton man has been charged with armed robbery and is being held under a \$25,000 bond in connection with the hold-up of the County Line Grocery last Friday

The man told Henderson it was a hold-up. Henderson dropped about \$1,000 on the floor at the end of the counter. The man told him to give him the money in the register and to "hurry up". The man got approximately \$755.00 from the

approximately \$755.00 from the register and turned to leave.
Henderson took out a .25 caliber pistol, pointed it at the man, and pulled the trigger, buth the gun did act go off.

Kenneth Brewer, 18, of Rt. 7, Box 494, Lumberton, was arrested in connection with the robbery, Monday, Nov. 10, said Barrington.

He said Lennie Locklear, 17, of Rt. 4, Box 876, Red Springs, is also under a heavy bond as a material witness.

The rifle used in the hold-up has not been found, he said.


