Ex-Sanatorium Director Receives '76 Trudeau Medal

Dr. H. Stuart Willis of Chapel Hill, former medical director of the North Carolina Sanatorium System for 21 years, was presented the 1976 Edward Livingstone Trudeau Medal during the American Lung Association's annual meeting in

The Trudeau Medal, named for the first president of the National Tuberculosis Association who devoted his entire life to the study and cure of tuberculosis, is presented annually by the American Lung Association to recognize an individual who has made an outstanding contribution in re-search on lung diseases.

Several years ago Dr. Willis traveled as a member of a high tanking American medical group touring Great Britian, Belgium, France, Denmark, Sweden and Norway as a representative of the National Tuberculosis Association to gather first - hand knowledge on what was being done to stem the ravages of tuberculosis in these countries. Several outstanding research projects were carried out under his supervision.
Dr. Willis was born in High

Point, North Carolina. He received his A.B. degree from the University of North Carolina in 1914. Prior to entering medical school, he served as assistant in biology for a time at Johns Hopkins and received his M.D. degree from that university in 1919, and an M.A. in 1920. He remained at Johns Hopkins until

1928 as an instructor in medicine.
