## **Man Draws Suspended Term For Assault**

District Court Judge Joseph Dupree sentenced a 22-year-old man to a 60-day suspended term in jail Briday after he pleaded guilty to an assault charge.

The sentence for Ernest Levon Parker, Jr., of Rt. 1, Box 107-A. Red Springs, was suspended for two years and Parker was fined \$75 restitution for Patricia Goodman Parker, who required medical at-tention after the defendant struck her about the head and body. Also fined court costs, Parker was cautioned not to assault the prose-

cationed not to assault the prose-cuting witness for two years.

Mike Kellis, Rt. 1, Wagram, was given a 30-day suspended sentence after he pleaded guilty to assaulting a 13-year-old boy. Kellis was ordered to pay \$27 restitution plus costs of action
