Manslaughter Plea Draws 7 To 10

A 25 - year - old Raeford man received a prison sentence of seven to ten years after he pleaded guilty to voluntary manslaughter during the May 3 session of Superior

Court.
In sentencing Melvin McLaughlin, Rt. 1, Box 536, Raeford, Judge D.B. Herring, Jr., recommended work release and consideration for parole at the earliest date available for the defendant.

McLaughlin had pleaded not

guilty to a charge of second degree murder, thereafter entering a plea of guilty to the lesser included offense of voluntary manslaughter which was accepted by the court. He was charged in the September 27, 1976 death of John D. Roscoe Graham.

James Earl Monroe, Rt. 1, Box 469, Raeford, entered a guilty plea May 3 to a lesser included offense of voluntary manslaughter and was sentenced to five years in the State Department of Corrections with a recommendation for work release program. Monroe's sentence was suspended and he was placed on probation for three years on conditions that he cooperate with his probation officer as directed, remain within the state of North Carolina and not change his address without permission, violate

no penal laws, and pay a fine of \$500 plus costs. Monroe was charged with the Dec. 23, 1976 murder of Johnnie Cecil Everette. Alfred Baker, Rt. 3, Box 148, Raeford, received a 16 month jail

term with recommendation work release program after he pleaded guilty to driving while under the influence of intoxicating liquor, third offense, and failure to comply with restrictions on his operator's license. Baker appeared in court May 5 for trial upon charges of DUI, sixth offense, and operating a motor vehicle while failing to comply with restrictions on the operator's license.

Alonzo Lee Harrington, Rockingham, pleaded guilty to third offense DUI and to a passing violation May 6. He was sentenced to 12 months in jail for the misdemeanor offense. Nathaniel Watkins, Lumber

Bridge, entered a plea of no contest on a worthless check charge May 3. He received a 90 day suspended sentence and was ordered to pay \$110.34 restitution to Gordon M. Treadwell, plus costs of action. Watkins was further ordered not to violate any state laws for a period of one year.

Amos Lee Jones, Rt. 1, Box 822,

Raeford, was sentenced to 90 days in jail, suspended, and fined \$100 plus costs after he pleaded guilty to exceeding a safe speed, no financial responsibility and displaying a fictitious registration number plate May 3. Jones was also ordered not to violate any state laws for two

Benjie Stephens, 520 E. Sixth, Raeford, pleaded guilty to a charge of shoplifting and was sentenced to six months in the custody of the Commissioner of Correction as a committed youthful offender. Stephens was placed on probation for two years and told to cooperate with his probation officer, remain within the state, violate no penal laws, comply with all directives of his probation officer, and pay a fine of \$100 plus costs of action.

Thelma Davis Barbour, P.O. Box 135, Raeford, was given a five day suspended jail term after she day suspended jain term after sine pleaded guilty to a stop sign violation. A charge of driving while her license was revoked was dismissed. Her sentence was suspended for six months on the conditions that Barbour violate no

state laws and pay costs of action. Lorraine Thompson, McCain, was given a prayer for judgment continued from term to term May misdemeanor trespass charge.
Judge Herring revoked the two

year suspended sentence of William Floyd Brown May 2. Brown, of Aberdeen, violated his probation conditions and will be assigned to the State Department of Correction of North Carolina. The court recommended work release for the

defendant.
Action abated on charges of carrying a concealed weapon and assault due to the death of the accused, Cleven Ertle Locklear.

Jake Barry Maynard, 311 Craw-ford St., Raeford, waived his right to have assigned counsel April 29 and pleaded guilty to a charge of felonious larceny. Maynard was sentenced to two years in jail, suspended for two years. He was fined \$400 plus costs of court and fined \$400 plus costs of court and ordered not to violate any of the

laws of the state.

Marvin Burns, Rt. 4, Box 54, Raeford, pleaded guilty to three counts of worthless checks and to one failure to appear charge. A woman drops a package on the floor of a store. Another customer in the store discovers the package and turns it over to the proprietor of the store. If the true owner of the property is never located, may the customer who found it and first acquired possession reclaim it from

the proprietor of the store?
Yes. By dropping it on the floor,
the woman unintentionally parted with possession. The customer who picked it up became the finder of lost property. The customer was not a trespasser and had a legal right to be in the store.

Property found on the floor of a place where the public is admitted is in most cases said to be lost, but property found on a counter, table, or seat is said to be mislaid. In the former instance, the finder is the keeper; in the latter instance, the proprietor of the place is the legal keeper for the true owner.
