Youth Draws Two Years On Break-in Charges

A sixteen - year - old defendant pleaded guilty to three charges of misdemeanor breaking, entering and larceny during Friday's District Court Session.

Judge Joseph Dupree sentenced Tommie Brunson, Rt. 1 Box 582, Raeford, to not less than one day nor more than two years as a youth offender on two of the charges, stipulating that the terms be served concurrently.
