Traffic, Assault Cases Heard

The following judgments were issued Thursday.
Steven Hammond, Rt. 2, Polkton, driving while license revoked, and no operator's license, voluntary dismissal by the prosecutor; driving while license suspended, pleaded not guilty, found guilty, \$200 and costs; defendant gives notice of appeal.

E-4 Alfred Lee Henley, Ft. Bragg, speeding 75 in a 55 zone, pleaded guilty; driving under the influence, second offense, pleaded not guilty, found guilty of the lesser offense of careless and reckless driving after drinking, 30 days suspended for 6 months, \$150 and costs, and complete successfully within 75 days the Drug and Alcohol Abuse School.

Albert Charles McQueen, Wagram, driving under the influence, and exceeding a safe speed, 90 days suspended for 12 months, \$150 and costs, and surrender license and not drive for 12 months.

The following judgments were issued Friday in Hoke County District Court. Judge Joseph E. Dupree presided.

In South Hoke

Center Opened

The night of October 13 was another giant step for Lumbee Regional Development Association, Inc. This was the official opening of the South Hoke Day Care Center.

The center is being housed in a community building that was built by a grant from the U.S. Housing and Urban Development Department as a Community Development Project. This is another project for LRDA in its continuing effort to meet the needs of Indian people.

The new center is licensed to provide day care services for 60 children from birth through 5 years, and is open from 6:30 a.m. until 5:30 p.m. Monday through Friday. South Hoke D.C.C. is also an authorized center through the state of North Carolina which makes it possible for the local Department of Social Services to place children there and will pick up the cost itself.

Mistress of ceremonies was Lynneettah Jacobs, Community Development Day Care director, General Community Program of LRDA. Her comments included many thanks to all the people who had a part in making available the community building for the purpose of the day care.

Elias Rogers of the Lumbee River Electric Membership Co-op Board of Directors and a member of the South Hoke community, gave a prayer of dedication for the new facility.

Words of welcome were given by Earl H. Oxendine of the LRDA Board of Directors. Oxendine recalled the many times that he had asked the residents of Hoke County to help and they did. He remarked to the parents and guests that they should be proud of having one of the finest day care centers in this area.

Frances Woods, the center director, and Gary Deese, the General Community Program director, introduced the center staff as well as LRDA staff personnel.

Kenneth R. Maynor gave compliments to the members of the staff of the new center for the tremendous job they were doing at South Hoke. Maynor also thanked the community for letting LRDA be a part.

The program that makes the day care center possible is similar to the federal programs that served the citizens after the Depression. Adolph Dial, chairman for LRDA Board of Directors, reminded the group that this center is possible through funds from both the state and federal governments. The center was designed to make available day care for low and medium income families. This will make it possible for mothers to work with the assurance that their children are receiving developmental child care.

James Martin, county manager, told the group that he was glad to see the community building used for a day care center. James Hunt, vice chairman of the Hoke County commissioners, had similar remarks.

The deputy director of LRDA, Von Locklear, told the group they had a center to be proud of. In his travels he has seen many day care centers and that LRDA operates some of the best that he has seen.

Refreshments were served as Miriam Oxendine and Willie L. Lowery, from the Lumbee River Native American Center for the Arts, provided music for the group.

This is the fifth day care center that LRDA is currently operating. The others are: Gospel Tabernacle, Rex - Rennert, Union Chapel and Wakulla.

Gary Don Eleby, McCain, driving while license revoked, 6 months suspended for 2 years, \$200 and costs, and not drive for 2 years except as provided for by law.

Wes Williams, doing business as Wesnell, Inc., Box 686, Raeford, failing and refusing to submit employment records as prescribed by the Employment Security Law, pleaded no contest, prayer for judgment for 5 years, costs.

W.A. McDonald, doing business as Raeford Cleaners, Raeford, failing and refusing to submit employment records as prescribed by the Employment Security Law, pleaded no contest, prayer for judgment continued for 5 years, costs.

Thomas Monroe, Rt. 1, Shannon, assault, found not guilty; prosecuting witness to pay costs for frivolous and malicious prosecution.

Tony Thompson, Lumberton, speeding 50 in a 35 zone, prayer for judgment continued, costs.

Glenn Dixon, Rt. 1, Raeford, worthless check, 30 days suspended, \$15 restitution to National Finance Co., and \$10 and costs.

Hiawatha McLaurin, Raeford, simple possession of marijuana, \$50 and costs, costs remitted.

Annie Rivers McPhatter, Rt. 1, Raeford, speeding 45 in a 35 zone, \$5 and costs.

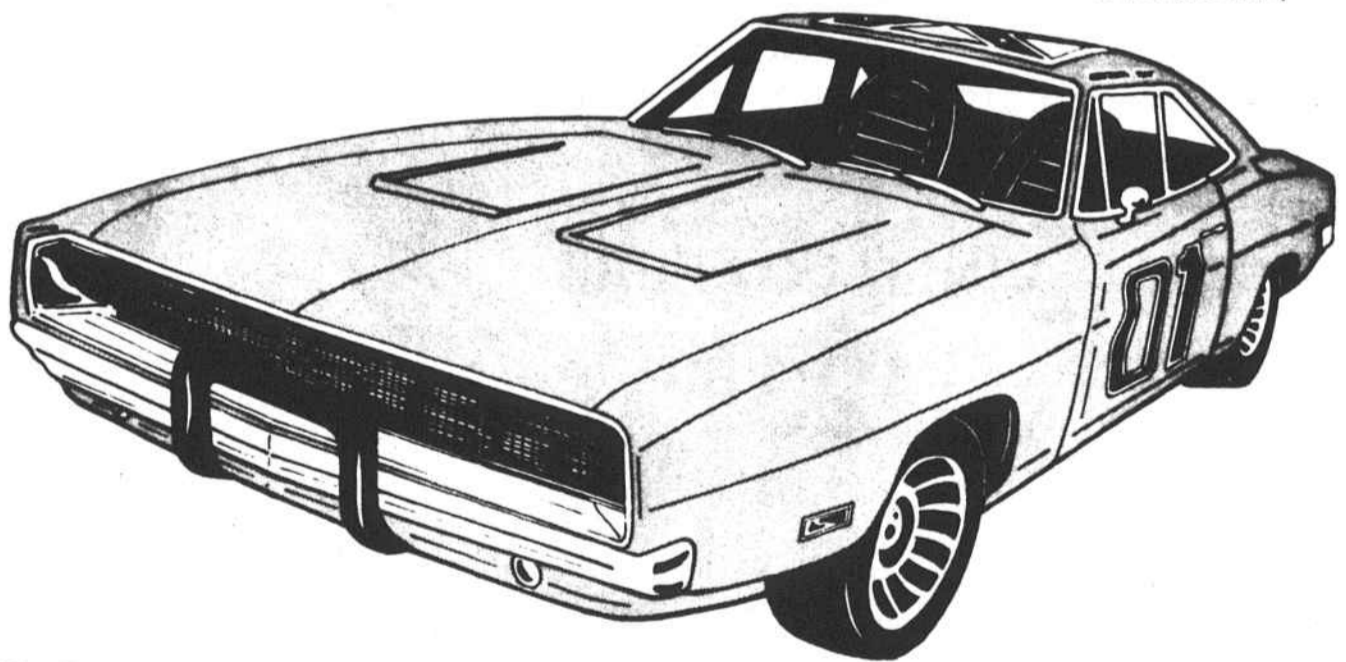
Gospel Singing
