

## In District Court

# DUI, Assault, Marijuana Cases Heard

The following Hoke County District Court judgments were issued Friday, Judge A. Elizabeth Keever presided.

Harley Cummings, Jr., Rt. 1, Box 323, Aberdeen, two counts, communicating threats, found not guilty of one, pleaded guilty to the other, prayer for judgment continued for five years, costs.

Dwight Green, Rt. 2, Box 501, Raeford, assault by pointing a gun, found not guilty, the court finds frivolous and malicious prosecution and taxes the prosecuting witness with costs.

Wallace Mac Lewis, II, Rt. 4, Box 96, Raeford, driving under the influence, pleaded not guilty, found not guilty, found guilty of careless and reckless driving after drinking, 60 days suspended for two years, \$200 and costs, and attend the Drug and Alcohol Abuse School.

Dallas Hunt, Rt. 1, Raeford, simple assault and assault and battery, found not guilty, the court finds frivolous and malicious prosecution and taxes and prosecuting witness with costs.

Stevie Franklin Tyndall, Box 906, Raeford, driving under the influence, second offense, 60 days suspended for two years, \$250 and costs, not drive till properly licensed, and attend the Drug and Alcohol Abuse School; driving while license revoked, voluntary dismissal by the prosecutor.

Alfred Parham, Jr., Rt. 3, Box 234-A, Raeford, driving under the influence, second offense, and driving in excess of 55 in a 55 zone, 60 days suspended for two years, \$200 and costs, not drive for one year or until properly licensed, and attend the Drug and Alcohol Abuse School.

Marvin Monroe, Box 416 Lumber Bridge, assault with a deadly weapon 18 to 24 months suspended for two years, probation for two years, \$733.69 restitution to Moore Memorial Hospital, pay rest, \$132.65, to Lester Monroe,

the victim; the defendant is allowed interstate travel as required by his job as a long-distance truck driver.

Thursday's judgments follow.

Judge Charles Lee Guy presided. Robert Dale Zimmerman, Rt. 4, Raeford, resisting a public officer, \$50 restitution for benefit of Raeford Policeman George Baker, and court costs; driving under the influence, pleaded not guilty, found guilty of careless and reckless driving after drinking, \$100 and costs, and complete successfully the Drug and Alcohol Abuse School within 75 days; assaulting Policeman George Baker, voluntary dismissal by the prosecutor.

Douglas Edwards, 2134 Coinjock Circle, Fayetteville, possession of less than one ounce of marijuana, and no operator's license, 30 days, suspended, \$75 and costs.

Miles Levon Jones, 209 Bethel Rd., Raeford, probation revoked, three sentences of six months each ordered into effect, to run consequently; revocation was ordered for violation a condition of probation: to undergo alcohol rehabilitation treatment, the violation being the defendant's refusal to take the treatment.

Dimato Mainor, Fayetteville, worthless check, 90 days suspended for 12 months, \$25 fine, and \$19.71 restitution to the prosecuting witness, Shoe Chest, and costs.

Daniel John Hopler, Seven Lakes, West End, speeding 66 in a 55 zone, pleaded not guilty, found guilty, prayer for judgment continued, costs.

David Earl Daniels, Rt. 1, Box 93-B, Lumber Bridge, failing to stop for a stopped school bus showing a mechanical stop signal, pleaded not guilty, found guilty, costs.

Terry Lee Webb, Fayetteville, driving under the influence, and resisting and obstructing a public officer, 90 days suspended for 12 months, \$200 and costs, surrender license and not drive for six

months, and complete successfully within 75 days the Drug and Alcohol Abuse School.

Jesse M. Jackson, 4420 Cliffdale Rd., Fayetteville, worthless check, 30 days suspended, \$1,236.71 restitution to the prosecuting witness, Marion Hollingsworth, and costs.

Kenneth Andrew Jackson, 1210 Stewart St., Raeford, breaking and entering, and larceny, voluntary dismissal by the prosecutor: evidence insufficient to warrant prosecution.

Terry Lee Webb, Fayetteville, assault on a law-enforcement officer, voluntary dismissal by the prosecutor: pleaded guilty to related charges.

William A. Gillespie, 713 Green St., Raeford, possessing stolen goods, and larceny, voluntary dismissal by the prosecutor: defendant has agreed to plead guilty to the charge of uttering.

Morris Dial, Rt. 1, Wagram, nonsupport, 30 days suspended, pay \$55 per week for benefit of children, and costs, and maintain insurance and medical expense for children.

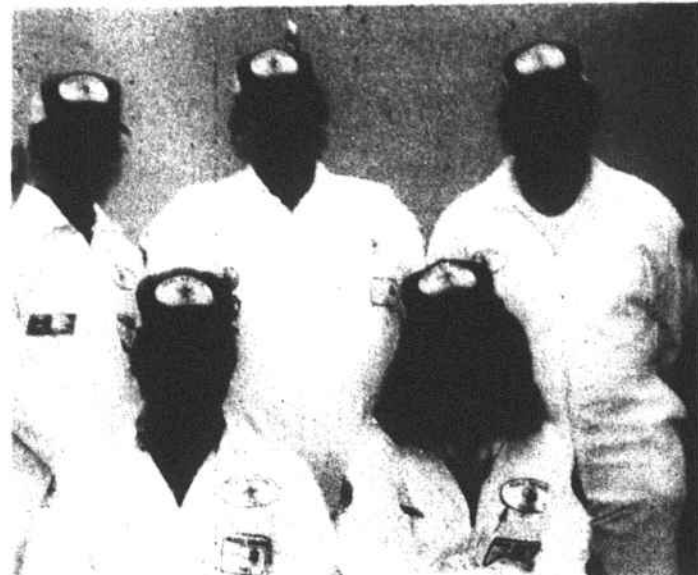
Marvin Conwell Stubbs, Rt. 3, Box 209-E, Red Springs, driving under the influence, and driving while license revoked, 12 months, defendant gives notice of appeal.

Benjamin Franklin Green, Jr., Rt. 2, Box 501, Raeford, driving under the influence of an alcoholic beverage, six months suspended for two years, probation for two years, \$100 and costs, not drive for one year or till properly licensed (left open for limited driving privilege), and attend the Drug and Alcohol Abuse School; two counts of assault on an officer and one of resisting an officer, voluntary dismissals by the prosecutor: the defendant has agreed to plead guilty to assault on an officer and DUI; assault on an officer, Maj. J.R. Riley, Sheriff's Department, pleaded guilty, six to 12 months

suspended for two years, probation for two years, \$500 restitution for Riley's benefit, and costs, and pay any non-paid medical bills for injuries arising out of this case; the defendant specifically consents in open court to be responsible for his own medical bills arising out of the incident.

Joseph Allen Green, Rt. 2, Raeford, three counts of assault on an officer, pleaded guilty, six to 12 months suspended for two years, \$100 and costs, and make \$113 restitution to Hoke County Officer John W. Wood and \$22.50 restitution to Hoke County, and costs; injury to personal property, interfering with, delaying and obstructing an officer, and assault on an officer, voluntary dismissals by the prosecutor: defendant has agreed to plead guilty to three counts of assault on an officer.

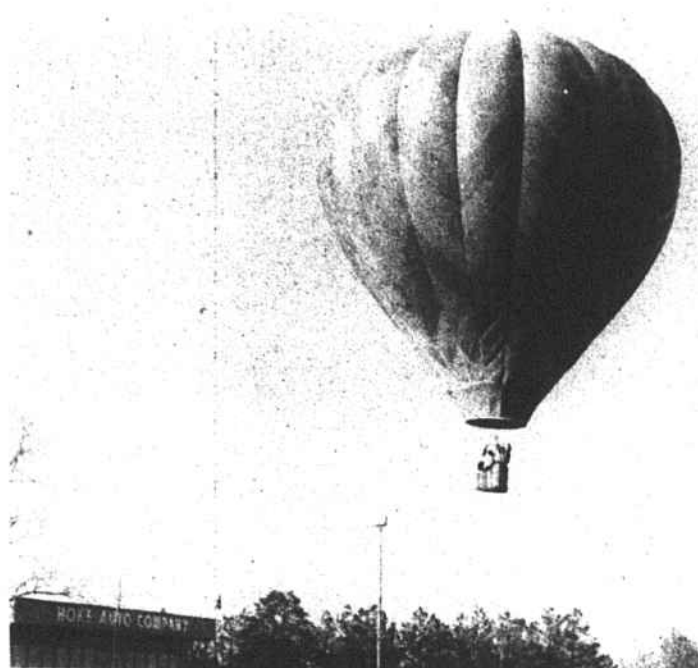
Jimmy Bullard, Rt. 1, Box 117-B, Aberdeen, injury to personal property and injury to real property, six months suspended for two years; probation for one year, \$200 restitution to Leander Jim Bullard, Sr., and costs, and not go on property of Jim Bullard unless specifically asked there.
