Raeford, was "shaken up," the officer said, and was checked at the scene by Hoke County Ambulance Service Emergency Medical Technicians.

Lee said Wichard was charged

with improper passing.

He said Barry Cribb, 16, and

3, Box 298 Raeford, were the other students riding in the truck, a 1980 Chevrolet Luv. The damage to the truck was "substantial." Lee

added.

He said the accident happened when Wichard was attempting to pass another vehicle as both were traveling south on SR 1143. He said the truck approached the intersec-tion too fast; the brakes locked as Wichard applied them.

Lee said the truck stopped in the west lane of SR 1149 after turning
