There was a time when eating was fun, one of life's real pleasures. That was before we Americans discovered that eating is hazardous to our health.

As youngsters, we were taught to eat several selections daily from the four food groups. Now, we're learning to be suspect of anything

Let's look at a typical breakfast. The bacon and sausage that we love so much have nitrites and fat. Our eggs have cholesterol. Hash browns are fried -- another no-no. Milk has too much butterfat. Our cereals, we're told, aren't really nutritious and we eat them with too much

sugar. Coffee is suspected of causing possible heart problems. This is breakfast, the meal mothers promote to their children as the most

important meal of the day. We could settle for a glass of water and that all-time favorite breakfast item -- toast. But, can we really trust toast?
