Limited-driving Privileges Revoked

The following judgments were issued Thursday in District Court. Judge Joseph E. Dupree presided.

Wilbert Brewer, Rt. 2, Maxton, driving under the influence, and transporting an alcoholic beverage container with seal broken, pleaded not guilty, found guilty, six months suspended for 12 months, \$200 and costs, surrender license and not drive for 12 months, and complete successfully within 90 days the Drug and Alcohol Abuse School.

John Frank Hobson, Jr., 233 Azlaca St., Raeford, limited-driving privilege revoked on court finding he failed to attend the Drug and Alcohol Abuse School as required by law and did not show just cause for failing to attend.

John Robert McLean, Rt. 4, Box 39, Raeford, limited-driving privilege revoked on court finding he failed to attend the Drug and Alcohol Abuse School and failed to show just cause for not attending.

Area Incidents

Motorcycle, Helmets Stolen

Raeford Police Chief Leonard Wiggins reported his department received the following complaints recently.

A motorcycle owned by Charles Baldwin of Rt. 3, Raeford, was reported stolen from the House of Raeford parking lot September 14, and two motorcycle helmets were reported stolen from a motorcycle owned by Odell Smith of Rt. 2, St. Pauls, the same day. The two motorcycles were parked side by side. Baldwin reported his motorcycle was a 1973 Honda 750 worth \$950, and Smith reported the helmets were worth \$65.

Hoke County Deputy Sheriff Jimmy Riley of 111 Birch Circle, Raeford, reported September 14 a girl's bicycle worth \$189 was stolen from his front yard.

Matthew McGregor reported September 15 the battery was stolen from his 1972 Chevrolet auto while it was parked in the Raeford Apartments parking lot. The thief did about \$10 damage to the cables in removing the battery.

A traffic accident about 4:10 a.m. Saturday on South Main Street just south of Edenborough Shopping Center cut off power temporarily in that and nearby areas.

A 1974 Chevrolet auto being driven north on South Main by Hubert Anthony Peterkin, Box 249, Keith Avenue, Raeford, ran off the street to the right and struck a power pole, clipping the pole in two. Peterkin was treated for injuries at Cape Fear Valley Hospital in Fayetteville. Wiggins described the injuries as minor. He quoted the driver as saying he fell asleep while driving.

The damages were about \$1,500 to the car and \$700 to \$800 to the pole.

Charles Andrews, who lives near Upchurch Junior High School, reported September 20 someone


stole a \$150 bicycle from his back yard.


