

Drug Defendants Are Fined In Hoke Superior Court

The following judgments were issued during the October 25 criminal term of Hoke Superior Court.

Beverly Bowman, Apartment 11, Raeford Hotel, pleaded guilty to possession with intent to sell and deliver marijuana, and sale and delivery of marijuana, two years suspended for three years, on conditions she pay court costs and a \$250 fine, and \$20 restitution to the SBI Drug Fund.

Robert Earl Middleton, Fayetteville, first degree rape, volun-

tary dismissal by the prosecutor; insufficient evidence to warrant prosecution -- the defendant was in the Veterans Administration Hospital in Fayetteville when the rape took place.

James Louie Locklear, P.O. Box 100, Raeford, nonsupport of child, found guilty, six months suspended, for five years, on conditions he pay \$25 weekly for child support, and court costs. The defendant gave notice of appeal to the Court of Appeals.

Michael Shane, Sandhills Youth Center, escape, pleaded guilty, one

year; the court finds the defendant would not benefit from being sentenced as a committed youthful offender; the sentence to start at the expiration of all the defendant is presently obligated to serve.

Larry Atkinson, Sandhills Youth Center, McCain, felonious escape, pleaded guilty, one year, to begin at the expiration of all sentences the defendant is presently obligated to serve; the court finds the defendant would not benefit as committed youthful offender.

George Vandewater, Sandhills

Youth Center, McCain, felonious escape, pleaded guilty, one year, to begin at the expiration of all sentences the defendant is currently obligated to serve; the court finds the defendant would not derive benefit from being sentenced as a committed youthful offender.

Ervin Proctor Johnson, Jr., Fayetteville, possession of drug paraphernalia, carrying a concealed weapon, one year, to run concurrently with sentence imposed in another case; defendant gave notice of appeal.

Carl W. Jackson, Box 115, Raeford, driving under the influence and driving while license revoked, pleaded guilty, six months suspended for two years, probation for two years, \$100 and costs, and not drive till he obtains a valid license, and attend alcoholic rehabilitation treatment as directed by the probation officer.

James Thomas White, Rt. 4, Box 25, Raeford, possession of marijuana, sale of marijuana, pleaded guilty, two years on each count, to be served consecutively, suspended,

probation for three years, \$250 fine, costs, and \$20 to the SBI Drug Fund.

Barbara Ann Campbell, Rt. 2, Raeford, possession of marijuana with intent to sell and deliver, sale and delivery of marijuana, possession of a counterfeit controlled substance with intent to sell and deliver, and sale and delivery of a counterfeit controlled substance, caffeine, represented to be amphetamine, two years suspended for three years, \$100, costs, and \$22 to the SBI Drug Fund.
