

The Hoke County Industrial Facilities and Pollution Control Financing Authority has determined to issue its revenue bonds in the principal amount of not more than \$3,250,000 for the financing of all or a portion of the cost of an industrial project and intends to submit to the Secretary of the Department of Commerce an application for approval of the project if the ssuance of the revenue bonds and the project are approved by the. Board of County Commissioners of the County of Hoke, North Carolina.

The project consists of the acquisition of approximately 6.2 acres of real property and an approximately 65,000 square foot existing manufacturing facility, and the acquisition and installation of machinery and equipment in such facility located at 315 North Bethel Road in Hoke County, Raeford, North Carolina for the manufacture of covered fine yarn.
