Hoke's unemployment rate dropped from 8.4 percent in October to 8 percent in November.

Vance County had the state's highest unemployment rate at 12.3 percent in November, mostly attributable to layoffs in the manufacturing industry. For the second consecutive month, Watauga County had the state's lowest unemployment rate at 2.2 percent.

Juvenile prevention project launched

The Blue Springs-Hoke County. Community Development Corporation has launched a new pilot juvenile prevention project aimed at reaching young people between the ages of 11-18 years old.
