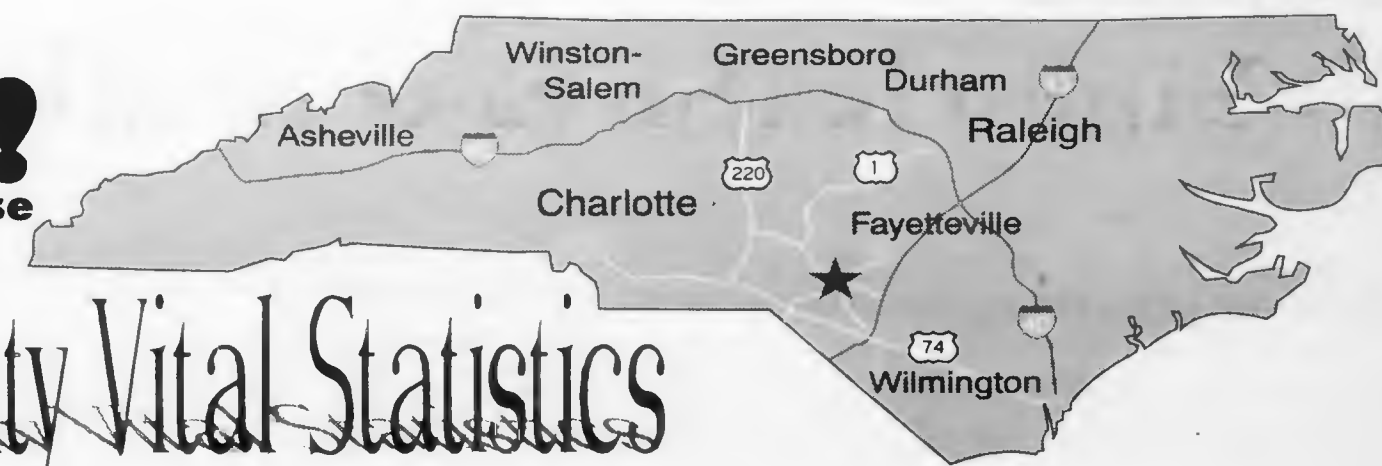

Hoke County Vital Statistics

HOKE COUNTY IS BORDERED BY MOORE, CUMBERLAND, ROBESON, SCOTLAND AND RICHMOND COUNTIES. THE COUNTY SEAT IS RAEFORD. IT ALSO HOLDS THE COMMUNITIES OF ROCKFISH, ARABIA, ANTIOCH, DUNDARRACH, DUFFIE, MCCAIN, FIVE POINTS, SOUTH HOKE, ASHLEY HEIGHTS AND TYLERTOWN.

Government

The county has a commissioner-manager form of government with five commissioners comprising the governing body.
The City of Raeford (county seat) has a council-manager form of government with five councilmen and a mayor making up the governing body.

City taxes are 49 cents per hundred dollar valuation. County taxes are 74 cents per hundred dollar valuation.

Financial Institutions

Three banks are located in Raeford: Centura Bank, BB&T and the Fidelity Bank. In addition, there are a savings and loan — Progressive S&L — and a credit union — the N.C. State Employees Credit Union. Other financial institutions include offices of Farm Credit Service and Farmers Home Administration, Safeway Finance, National Finance Company and the Industrial Revenue Bond Authority.

Education

The county has a consolidated county-wide public school system, operated and administered by an elected board of education, which appoints a superintendent.

There are 11 public schools in the system. Enrollment as of January 2000 was approximately 6,000. Schools include: Hoke County High, East Hoke Middle, West Hoke Middle, Turlington, J.W. McLaughlin Elementary, Scurlock Elementary, West Hoke Elementary, South Hoke Elementary, Rockfish-Hoke Elementary, Sandy Grove Elementary and Upchurch Elementary.

Library

The county operates a public library with approximately 40,000 books, periodicals and other resources. The library is a member of Sandhills Regional Library System, serving Anson, Hoke, Montgomery, Moore and Richmond counties. The library has an out-reach program for elderly and shut-ins, and story hours for children.

Recreation

The county operates a recreation program, providing organized sports and activities for all ages. Basketball, volleyball and softball leagues are organized for adults. Baseball, soccer, basketball, and football are among sports offered for youth. A number of activities are offered for senior citizens.

Emergency Services

The Hoke County Sheriff's Department provides law enforcement in Hoke County; the Raeford Police Department in Raeford.

Fire protection and rescue service are provided by 10 volunteer fire departments and a volunteer rescue squad.

Dispatching for all of these services is provided at a central location, and can be reached from most areas of the county by dialing 9-1-1. Other areas (not on 875 or 904 exchange) can reach emergency assistance by dialing 1-800-842-9111.

The fire departments are: Hillcrest, Rockfish, Puppy Creek, North Raeford, West Hoke, Stonewall, Pinehill, South Antioch, Tylertown, and City of Raeford volunteer fire departments.

Rescue and emergency medical services are provided by Hoke County Rescue Squad, FirstHealth of the Carolinas provides emergency medical and ambulance service.

Utilities

Electricity is provided by Carolina Power and Light Company and Lumbee River Electric Membership Corporation.
Natural Gas Service in some areas of and surrounding Raeford is provided by the North Carolina Natural Gas Company.

Communication

Cable television service is provided in Raeford by Time-Warner Cable and in Hoke County by Milestone Com-

munications.
Telephone Service is provided by Sprint.

Hoke County has two weekly newspapers and a radio station. Home delivery of Fayetteville and Raleigh dailies is available. A Charlotte daily is available in racks.
