## NOTICE OF EARLY PUBLIC REVIEW Floodplain Management (Executive Order 11988)

Hoke County is reviewing the project shown below to determine whether any environmental factors pose a risk to proposed activities or whether the proposed project might adversely impact the human or natural environment.

NAME OF PROJECT: Hoke County FYO3 CDBG Scattered Site **Housing Program** 

ADDRESS OF PROJECT: Hoke County, North Carolina

The Hoke County FY03 CDBG Scattered Site Housing Program is a rehabilitation project to address substandard housing needs in Hoke County. The total project cost is \$400,000, of which 100% is being financed with FY03 Community Development Block grant funds provided by the North Carolina Division of Community Assistance. Project funds willbe used for the rehabilitation of ten (10) residential dwellings.

According to the U.S Corpos of Engineers, Wilmington District, project activities are located in the 100-year floodplain established by the Federal Emergency Management Agency (FEMA). The Division of Community Assistance and Hoke County are required by Presidiential Directive E.O. 11988 not to support the project if there are practical alternatives to performing it in the base floodplain. Accordingly, an analysis will be prepared, and the county will define mitigative measures to be taken during housing rehabilitation activities, if required.
