AGAINST POLYGAMY. The National House of Representa tives, through its committee on election of Bresident and Vive-President, agreed on approposed amendment to the constitution of the United States to bar polygamy, as follows:

Amendment to the constitution prohibiting polygamy within the United States and disqualifying polygamists por election as Senators or Representalives in Congress."

The resolution submits to the Legis lature of the States an amendment to the sections of the constitution giving the age and other requirements of Senators and Representatives so that notygamy shall be included as a bat o service. A new article of the constitution is provided as follows:

"Article 16.-Section 1. Polygam; shall never exist within the United States or any place subject to their ju isdiction. Section 2. Congress shall have power to make all needful laws to enforce this article and pinish "I Civilar Frett."

However, the House in its wisdom, saw fit to exempt from these provisions "present investments' of educational and charitable institutions. Mr. Thompson's bill now seeks to change this Stevens bill and not ellow these semi-religious institutions to do with impunity what private citizens are prohibited from doing. 
