Mrs. Bernstein M. Moore Claims That Sewer Gas Poisoned Her.

Chicago, March 17.—Mrs. Bernstein M. Moore has a grievance against John W. Anderson, her former landlord. She thinks about \$7,000 will square matters. THINKS THAT WOMEN SHOULD PROPHECY.

Rev. A. C. Dixon Gives His Views on the Subject of Women Prophecy.

Dr. A. C. Dixon, of the famous New York divine, at the meeting of the Bible Society yesterday, gave his views on the question of whether women should prophesy. He said: "I believe that women ought not to be officials in the church as preachers or any other capacity. Man is the head of the home, the church and the state. But the Scriptures teach plainly that women should prophesy, which means speak for the Lord. Paul told the women at Corinth to prophesy and pray in public with heads covered, and he did not mean to tell them to do the wrong thing in the right way. "In the Scripture quoted by Peter on the day of Pentecost, Joel said your sons and daughters shall prophesy when the Spirit shall come upon you, and in the fulfillment of this prophecy men and women were filled with the Holy Spirit and spake with other tongues as the Spirit gave them utterance. "Philip, the evangelist, had two daughters who were evangelists like himself. Every Christian woman has a right to speak for Christ before any company of men or women, however small of large. WADESBORO SELECTED.

A dispatch from Princeton announces that Professor Charles Young of the University Astronomical Department announced today that preparations are now being made by him to observe the total eclipse of the sun, which will take place on May 28th. The instruments for the work are in course of construction.

Wadesboro, N. C., has been selected as the place where the best observations can be made and a party of Princeton professors, under the direction of Professor Young, will leave here for that point two weeks prior to the date of the eclipse. The work undertaken will be mainly spectroscopic, including particularly a determination, both visual and photographic, of the position of the corona line. Several sets of photographs of the eclipse will be taken.

HELP TO LONG VOYAGE SAILORS.

Saving of \$50,000 Annually Under New Shipping Law.

By Telegraph to the Times-Vision. New York, March 17. The new shipping law will save sailors about \$50,000 a year according to United States Shipping Commissioner Doolay. The boarding house keepers will hereafter be allowed only one month's advance wages of the seaman, a saving of \$25 for each seaman starting on a long voyage.
