By Robert Schmidt I have just received a copy of the N. C. State Fair catalog which reminds me that many community and county fairs will be held during the next six weeks.

Before you enter an exhibit, read over carefully the instructions in the catalog. Be sure to enter the exhibit in the proper class, and have it properly labeled.

Answer: Yes. The price you receive for beef cattle varies with the grade and the month when sold. Each grade has a seasonal price pattern.
