To the Membership:

By the authority vested in me, I hereby call the regular annual communication of the National Union, Farmers Educational and co-operative Union of America to convene in the city of Shawnee, Oklahoma, on Tuesday, September, 5, 1911, the time fixed by the Constitution for holding said meeting.

"Each State shall be entitled to one delegate for each five thousand members or majority fraction, the number being ascertained by taking one-fourth of the dues paid during the twelve months just preceding the National meeting." Any State shall be entitled to one delegate.
