## Elkin Man Succeeded By W. R. Badgett, of Pilot Mountain

The dry forces of the county are continuing with unabated force their campaign to carry Surry in favor of continued enforcement of the Eighteenth Amendment. County dry leaders state that the sentiment is growing more dry each day.

One development of the campaign came when Earl James, of this city, who had been appointed as a dry candidate to run in the November election, withdrew his name from the ticket. W. R. Badgett, of Pilot Mountain, has been appointed to fill his place.

The election will be held Tuesday, November 7.
