PRESS COMMENT ON BRYAN'S NOTE TO GERMANY

The comment of the independent and partisan press on Secretary of State Bryan's note to Germany, in answer to the intimation that the United States was unwarred, in selling the implements of war to the Allies when Germany could get nothing from us, has been one of the highest compliments any Secretary of State has ever received. The New York Sun which has been hostile to the Administration ever since Wilson came in, and especially to Bryan, pronounces it a "master-piece." And in doing nearly all of the Republican editors have been similarly eulogistic. As a master-piece of diplomacy and unanswerable logic on a most delicate international problem, it is unsurpassed by any state papers of Jefferson, Webster, Seward or Blaine. The opposition papers have indulged in much criticism of Mr. Bryan in the evening features throughout the country, claiming that they indicated neglect of his duties as Secretary of State. Bryan has shown them that he can lecture more than half the time and they match any diplomat who tries to outstep our state Department. It is now pretty evident that the bitterness of the attacks have been made on the ground that the Secretary of State, who controls editorial and editorial matter in the papers so that they do not attack or other grounds on which they have only seemed to read and were to have their own to the starting of the attacks who constitute the great trouble chest and the great trouble chest of the country.

PROSPERITY SWEEPING OVER THE COUNTRY

By a degree of confidence in the stability of the fact that a broad and general wave of prosperity is sweeping over the country. One of the best of proofs is the large volume of the U. S. Steel corporation which not only has for March and April sold million dollars against four and a half million. This shows that the confidence and building construction are very active and prosperous again. The American locomotive works with plants in Virginia, Pennsylvania, New York, Ohio and other places has already received orders that will keep them busy for more than a year. And most of all our exports to foreign countries are running at an increase over all records of about four hundred million dollars per annum, and South America is just launching two new steamship lines, one from Buenos Aires, Argentine, seeks to aid in taking care of the rapidly increasing trade between them and us.

Since the Greenville, N. C. Reflector: "A new three-story hospital has just been completed at New Bern. Kingston, Wilson and Washington and other towns near us have hospitals. It seems that somebody ought to start a movement for one here, for this is certainly something the town needs."

By all means Greenville should have a hospital. That town is a live-wire place, and we are surprised to know that it is lacking in such a necessary institution and we venture the assertion that if the Reflector will whoop things up for a while, that such will be secured. New Bern Daily Journal.

There is plenty of speculation as to what may come after the war in Europe ends. But first we would like to see the war end, and there is no telling what may happen before the struggle terminates.

Now and then there is some talk about Greenville's population, and it is not unusual to hear some one ask how many people are here. The Government census of 1910 credited the town with 4,191 persons within the corporate limits. That was five years ago, since which time there has been steady growth, and the Reflector believes a conservative estimate of the population now is 6,000. Not long since someone canvassing for a directory gave out the statement that the population was a little above 4,500, but that estimate was given little credit. As the voting strength of a community is usually placed at one-fifth of the population, some calculation of the number of people here can be made from the primary for mayor of Monday. In this primary 512 votes were cast, all of them by white people, and it can hardly be said that every white man in the town voted, in fact a number did not vote. But on a basis of five to one for the votes cast, it would appear that Greenville has more than 2,500 white citizens. Then when it is taken into consideration that the population is pretty nearly evenly divided between white and colored, it is a safe guess to say that Greenville has about 6,000 people. Take into the count the immediate suburbs adjoining the corporate limits and the number will exceed that figure.

Even if business is picking up and times improving, the man who has a job should hold it down. Employment is not the easiest thing to find just now.

Can't we start another factory or two in Greenville this year?

Tuesday Morning Greenville Was Visited by Hard Rain and Hail

About 4:30 Tuesday morning Greenville was visited by one of the hardest hail storms that has struck this section in some time. The whole city was awakened during the early morning hours by the severe beating upon the houses and buildings, and the sounds of the beats and the terrific thundering and sharp lightning gave cause to much excitement. The hail was large in size and the cracks as it hit the roofs was enough to wake up the soundest sleepers. It came down through the chimneys in many of the houses and this morning the signs of the storm could be seen upon the streets for several hours.

Fire Whistle Blows.
About 4:55 the Fire Whistle blew and it was thought by many that the alarm was notification by the night watchman of the advancing storm. Supt. H. L. Allen, of the Water & Light Commission informs us today, however, that the alarm was due to the beating of the hail upon the wires and that when the watchman of the Power Plant made investigation, he found the door to little box on top of the building, where the alarm apparatus is located, wide open. So the hail gave its own alarm.

A great deal of damage was done, but nothing of a serious nature. Windows were broken in many of the residences and the gardens and flower plants were hurt in many instances. Mr. D. D. Haskett, Florist, says his flower plants were damaged to a great extent.

MR. JOHN W. AYCOCK DIED EARLY THIS MORNING

Was Well Known Here Where He Lived Several Years, Being Cashier of National Bank.

Mr. John W. Aycock, Cashier of the Planter's Bank at Rocky Mount died this morning about 5 o'clock. A telegram was received here announcing his death. The funeral will be held tomorrow afternoon.

Mr. Aycock had been troubled with cancer of the stomach for several years and was down for sometime last year. He has been able to get out some since then, however, and the length of his last confinement is not known here.

Mr. Aycock was well known in Greenville, having lived here for several years. He moved to Greenville and became the first Cashier of the National Bank on its establishment in 1906. He remained as Cashier for about a year and a half, going to Rocky Mount to accept the position of Cashier in the Planter's Bank, which position he held at his death.

Mr. Aycock had many friends in this section of the State and was very popular in banking circles. The news of his death has brought sadness and sorrow to his large number of friends in Greenville.


