ARTICLE VI. Suffrage and Eligibility to Office.

ction 1. Every male person born in he United States, and every male person tho has been naturalized, Iwenty-one cears of age, and possessing the qualiations set out in this article, shall be ntitled to vote at any election by the copie in the State, except as herein therwise provided. Section 2. He shall have resided in the State of North Carolina for two years, in the county six months, and in the precinct, ward or other election district in which he offers to vote four nonths next preceding the election: Pro-

vided, that removal from one precinct ward or other election district to another in the same county, shall not operate to deprive any person of the right to vote in the precinct, ward or other election district from which he has

emoved until four months after such emoval. No person who has been convicted, or who has confessed his guilt in open court, upon indictment, of any

crime, the punishment of which now is, or may hereafter be, imprisonment in the State's prison, shall be permitted to vote unless the said person shall be first restored to citizenship in the manner prescribed by law.

Section 3. Every person offering to rote shall be at the time a legally regis tered voter as herein prescribed and in the manner bereafter provided by law, and the General Assembly of North Carolina shall enact general registration laws to carry into effect the provisions of this article.

Section 4. Every person presenting himself for registration shall be able to read and write any section of the constitation in the English language: and, before he shall be entitled to vote, he shall have paid on or before the first day of May of the year in which he proposes to vote, his poll tax for the previous year as prescribed by article 5, section 1, of the constitution. But no male person who was, on January 1st, 1867, or at any

time prior thereto, entitled to vote under the laws of any State in the United States wherein he then resided, and no lineal descendant of any such person shall be denied the right to register and vote at any election in this State by reason of his failure to possess the educa tional qualification herein described Provided, he shall have registered in accordance with the terms of this section




