There were plenty of oysters in the narket again yesterday and a big fleet of costs was at market dock.

A car load of horses has been received by Mr. J. M. Arnold at his Broad street able. They are fine animals.

Fish were in fair supply yesterday for the retail trade, mainly mullet. Only one shad is reported to have been seen a white shad, caught some days ago. The Life Insurance Company of Virginia has established a branch office of the company at Kinston. Mr. R. J. Disosway will be the agent and left yester-

Civil Service Catalogue.

The U. S. Civil Bervice Commission will hold examinations at several places in each State during March and April, to secure young men and women for the government service. 9,889 persons secured positions last year through these examinations. Probably 10,000 appoint-ments are for life and for most positions only a common school education is required. Salaries at appointment vary from \$860 to \$1200 a year with liberal promotions afterward. Politics is not considered. There is less competition in the Southern States than in other parts of the country. This affords a good opportunity for people between 16 and 45 years of age. Those desiring places of this kind can get full information about them, free, by writing to the Columbian Correspondence College, Washington, D. C., and asking for its Civil Service catalogue, number three.

A KINSTON FIRE.

Marrow Bscape From Destruction of Muci

V aluable Property. A terrible configuration was averted in Kinston this morning by the just in uick of time interference of Providence, the hard and intelligent work of the Kinston Fire Company, the Dread Not Hook and Ladder Company and other

At one time it looked to be almos ertain that the tobacco section of the lown would be swept away, and no telling where the fire would eventually

The alarm sounded at 10:15 o'clock. It was first given by the whistle of the American Tobacco company's plant and in a few seconds later by the fire

but a group of small wooden buildings on the corner of Heritage street and Ver warehouse, consisting of a small confectionary store run by Mr. Norman B. Observer and the Coaster of Morehead White, and two tobacco hogshead factories, one of them owned and run by Capt. J. M. White and the other run under the firm name of the Kinston Hogshead Co. owned by Messrs. Fleming, Bobbit and Goodson.

A strong northeast wind was blowing, which at first took the burning cinders towards the Carolina Warehouse. The tobacco stored there was removed, and by close watch, putting the flames out as the warehouse caught, the fire was prevented from spreading there.

The greatest danger of all now loomed up. The three story prize house and stemmery occupied by Messra. Bobbitt and Moseley and Mr. J A Long, situated directly across the narrow street from the flames, caught fire. The wind seemed to dip down and, taking the flames, burning cinders and thick black smoke, hurled it against the west side of the three story building. This, of necessity, drove the crowd and all who were fighting the flames back, and it seemed beyond hu man skill to prevent a fire that would consume thousands and thousands of dollars worth of property. But history repeated itself (as to Kinston fires) and once again Providence came to the rescue. The wind changed to northwest, and then some of the pretticst work ever done by the Kinston fire department was put into execution, and with the two streams of water and the ladders of the Dread-Not Hook and Ladder company, the fire was gotten under control.

The fire was first discovered on top of an old discarded building, which was used as a store house by Mr. A. Mitch-

The stock in the store and all the hogsheads in the two factories were

The loss on these buildings was small, everal hundred dollars covering the entire loss. Messrs. White and Son had their loss covered by insurance. The others had no insurance. The prize house and stemmery was damaged to the extent of several hundred dollars. It is owned by Messrs. S. H. Abbott and . W. Grainger and the loss is covered by insurance.-Free Press, 18th.
