LOCAL INDUSTRIAL EFFORT DEMANDED.

There is too much local self-complacency, over the industrial and material development and growth of this city.

The fact that never has there been so much building going on, building of a good character, at this time of year, is a matter of congratulation, but this building is not the outcome of any special local industrial effort.

Putting up new store buildings amounts to nothing, unless there be business to demand them.

All present desirable store buildings in this city are really scarce, the result being that tenants must pay in many instances high rent, for most indifferent quarters.

The present increase of store buildings means a better future for tenants, as there will be some choice of quarters offered, whereas for some time past, any kind of building had to do.

But to fully sustain this new building boom, there should be some local effort to create or bring new business to this city.

In other cities, chambers of commerce originate schemes to attract trade to their merchants, or the merchants themselves organize, and promote plans which mean the bringing into their cities great crowds of people who will want to buy goods.

Nothing of this kind is being done in New Bern. Each merchant is left to shift for himself, when a union of the local mercantile forces would mean much more.

Now is the time to both plan and put into motion, plans which will bring business to New Bern this fall.

There is trade to be secured but it must be sought with intelligence and some concert of local effort, if it is to be secured.
