GOOD STREETS BY RAILROADS.

It was with no thought of partiality that the Journal first made the Atlantic Coast Line the subject for editorial reference in the matter of Good Streets. The Norfolk Southern calls for like attention, for this railroad enjoys many privileges, and yet has the worst street along both sides of its track from Queen to South Front Street, of any in this city except Queen Street.

There is every reason for the Norfolk Southern at once paving Hancock street from Queen to South Front street. One reason is that this street is used fully two-thirds by traffic which directly concerns the Norfolk Southern Railroad Company's interests.

Another reason, that largely hinges upon the first, is that as Hancock street is almost entirely the Norfolk Southern's, the residents along the street should have just protection against the dust in dry weather and the mud holes in wet weather. Those who travel by vehicle on this street are entitled to good roads protection, the protection that only can be found by substantially paving this street, making it equal to the \$100,000 worth of paved streets in New Bern.
