Some very large Irish potatoes were brought to the JOURNAL office Tuesday.

They were raised by Mr. S. B. Wright on the farm of Mrs. W. T. Taylor about eight miles from the city. This has been an unusual season for vegetables. Good quality of beans and peas have been shipped North and strawberries and potatoes all raised here in the latter part of November.

### Steamer Movements.

The Eagle of the E. C. D. line arrived yesterday morning and sailed yesterday afternoon with full cargo. The Veep of this line arrived last night and will sail at 4 o'clock this afternoon.

### Conference Notes.

About two hundred and fifty members of the M. E. Conference arrived last night and were assigned homes by the committee of reception.

The various committees on examinations were in session yesterday and a large number were examined. There are about twenty-five applicants for admission.

Bishop Granbery and the Presiding Elders were in consultation yesterday on the work of the incoming year. All the Presiding Elders were present, and we are pleased to learn, all enjoying good health.

### The Superior Court.

Court convened on Tuesday morning at 10 o'clock, Judge Montgomery presiding; Solicitor White representing the State.

Mr. John S. McGowan was sworn as foreman of the grand jury. His Honor's charge was one of force and clearness, touching upon practical matters, and impressed the jurors and attendants with the importance of maintaining good government.

The State docket, numbering over three hundred cases, many of which were matters of cost which the taxpayers of the county will have to dance up to, was called and cases noted for trial.

In the afternoon session two cases went to the jury: State vs. Augustus Lancaster, A. & B., verdict not guilty; State vs. Ernest Rowe, L. & R., verdict not rendered at this writing.

### Our Dead at Hollywood Cemetery.

Last summer the JOURNAL appealed to the citizens of New Berne to contribute to the fund, now being raised, to place tombstones at the graves of North Carolina Confederate soldiers buried at Hollywood Cemetery, Richmond Virginia. A good many of our people responded to that appeal, but there is yet a deficiency that must be supplied. On yesterday we had a visit from a lady of New Berne, who is deeply interested in this subject. She has lately visited Hollywood, and was pained to see how few of the graves of North Carolina soldiers are properly marked. Most of them have had head boards of common pine boards, but they have decayed and fallen down. The good people of Richmond keep the graves in order, but they expect the people of the different States to furnish the simple marble slabs that record the names of the sleeping heroes. Again we ask contributions to this sacred cause.

### A Fine Colt.

Our townsman, E. M. Pavie, Esq., has the finest colt seen on our streets for many years. It is just six months old today and weighs 515 pounds. It is a beauty and is of high grade stock, being sired by "Gold Dust," owned by Joel Kinney, Esq. of this county.

We sincerely trust that the organization of our Fair will stimulate our farmers to raise their own stock. The amount of money sent from Eastern North Carolina annually to buy mules and horses would astonish any one who has not taken the trouble to estimate it. Special premiums ought to be offered at all Fairs for native stock.

### Make It Buzz.

Judge Montgomery was very much astonished yesterday after calling a docket of over three hundred cases and seeing the enormous costs that are piled up for the taxpayers of this county. Said he, "I don't see how the taxpayers stand it. If such costs were put upon the people up in my country they would make it buzz around somebody's ears."

The JOURNAL called attention to these things several years ago, and it was done pointedly, in fact so much so that some of our friends thought we were too personal. We are of the opinion that the taxpayers of this county will never be relieved of such unnecessary costs by alluding to the matter in general terms. The fault must be traced to those responsible and they must be held to account. Until this is done, there is no use growling and grumbling. Until the moral sentiment in the community gets sufficiently healthy to condemn wrong, no matter by whom perpetrated, the taxpayers and the Judges might just as well sing easy and pay up. Make it buzz around the ears of those who are responsible for much of the unnecessary costs thrown upon the county, and keep up the buzz until it is stopped.

### Work at the Fair Grounds.

The greatest activity prevails at the grounds recently purchased by the Fair Association. The main building, which is one of the finest in the city, has been thoroughly renovated. It has ten rooms which will give ample space for exhibits of fancy work, taxidermy, fish, game and oysters, farm products, etc. Machinery hall is about completed. It is of brick 32x33 with large doors and windows. The stables, with forty stalls, are of modern build and are nearly completed. The grounds are being beautified and put in first class order.

Again we wish to commend the wisdom and foresight of the Directors in purchasing these buildings and ground. The improvements made and the construction of the road from the federal cemetery will more than double the value of the property.

Our farmers in the surrounding counties ought to take a lively interest in the Fair. They ought to become stockholders and have a voice in directing its affairs. An annual exhibit here of the products of the farm and forest, sounds and rivers will aid them materially in developing their resources, and stimulate every department of industry to renewed efforts to build up home and become independent of foreign industries.

When the improvements now in progress are completed the stockholders will be invited up to inspect the buildings and grounds, and we trust it will be an occasion that will draw new friends to the Fair, such as will desire to give material aid.

Startling Developments Expected.

CHICAGO, November 26.—The Mail this afternoon prints the following:

INDIANAPOLIS, November 26. The startling developments that are expected to follow the indictment of bribers at the recent election will shake Indiana to its center. Many of the names sent into the United States District Attorney for offenses against the State are those of men prominent in the Republican party, chairmen of county committees, county officers of note, and men whose reputations have extended beyond the State, and who were known in the past for their integrity and uprightness. Over a thousand complaints have been filed at the office of U. S. District Attorney Sellers. The most scrupulous care is being exercised in arranging the cases. Not a man will be brought before the grand jury whose evidence cannot be corroborated, and no case will be presented without the most convincing evidence. A man in Dearborn county, it is said, was offered \$1 a day for a year to change from Cleveland to Harrison. A man convicted in the United States Court for counterfeiting four years ago, was re-arrested before the expiration of his term, and on election day he was taken to the polls by the sheriff and allowed to vote. In Monroeville two witnesses will swear that they saw a voter receive a sum of money and an overcoat from a well-known Republican, and all for a vote for Harrison.
