THE Superior Court.

Court convened at 9:30 Wednesday morning. The case of State vs. Lemuel Hatch for the murder of John Alex. Harris, was taken up. L. J. Moore, Green & Stevenson, Duffy & Nixon, and Jas. W. Waters appeared for the prisoner, Solicitor White for the State.

A special venire of one hundred had been summoned from which and the regular panel, the following jurors were selected: W. T. Hawkins, N. S. Richardson, Alfred Dudley, Geo. West, W. H. Adams, F. W. White, W. W. Prescott, Chas. Sutton, A. W. Nelson, L. E. French, Virgil Sparrow, col., and Bryant Wiley.

The State proved a clear case of killing; that Hatch, the prisoner, came out of the store of E. N. Duffy and fired a pistol at Harris, who was standing with his back to the prisoner, and fell and died immediately.

The evidence for the prisoner was, that he, with Harris, the deceased, and two other boys, were at or near the railroad depot on the evening of the killing, that Harris struck the prisoner several blows at different times; that the prisoner started off down Hancock street and that Harris and the other boys followed. Harris saying to Hatch, "If you have me arrested I will whip you and pay for it;" that he followed the prisoner down to the drug store where he was employed; that Hatch went into the drug store at the rear and while the others went on to the corner and stopped; that Hatch walked out and fired the pistol, the ball taking effect behind the right ear, killing him instantly. It was also proved that it was not more than half an hour from the time of the fight at the depot and the killing, and that Harris followed Hatch down to the store from that point. When the testimony was concluded, the Solicitor, after consultation with the prisoner's counsel, stated that he heard the testimony before the Justice, and that the testimony now was so much stronger for the prisoner, that he was satisfied that owing to the youth of the prisoner, and the manner in which the testimony showed, he had been abused and followed up by the deceased, he doubted whether there was sufficient time for cooling between the trouble at the depot and the shooting.

Under the circumstances he thought it best to accept the proposition of prisoner's counsel to take a verdict of manslaughter. Counsel for prisoner readily assented, and His Honor stated that he did not object to his being known that after hearing the testimony he had advised the Solicitor to take that course as he would be compelled to charge the jury that they could not find a verdict of guilty of murder upon the testimony. The verdict agreed upon was, not guilty of the murder as charged, but guilty of feloniously taking the life of John Alex. Harris.

Court took a recess until 3 p. m.

When the court re-convened, work was resumed on the State docket.

H. B. Griffin, convicted for A. & B. on H. J. Ostrawan, was fined \$1.00 and cost and required to give bond in the sum of \$500 for his good behaviour.

Clairo Wood, colored, indicted for the larceny of lint cotton from the cotton platform, was found not guilty, or it was not proven. L. J. Moore, Esq., appeared for the defendant.

Matthew Bell, colored, stood charged with breaking into the store of S. E. Scott for the purpose of stealing goods, etc. Matthew appeared for himself and testified for himself, stating that he went into the store but was hired to do so by a man who said his name was Henry Green. Verdict, guilty. Judgment, seven years in the penitentiary.

Henry Erice, charged with stealing a peck of corn. He submitted, his counsel, W. E. Clarke, Esq., stating that he was so much under the influence of liquor at the time that he knew nothing about taking the corn. Judgment was suspended on payment of cost.

Edward Holly, Nathan Brooks and Thomas Chapman were called to answer to the charge of having an affray. Holly submitted. L. J. Moore appeared for Brooks, O'Hara for Chapman. Verdict: Brooks guilty, Chapman not guilty. Brooks and Holly were fined \$1.00 and cost each.

James Daniels and John Daniels, two young colored striplings, were put on trial for the larceny of shoes from the store of M. H. Sullivan. O'Hara for the boys, Solicitor White for the State. Verdict, not guilty. (Another case of guilty but not proven.)

James Williams alias Havens or Hogan, the boy who broke into Mr. Steinhilper's house and ran into the river, pleaded guilty to the charge and asked the mercy of the court. His father has gone before him to the penitentiary and left him a very bad character. His Honor, in consideration of his good nature, gave him only six years in the penitentiary. He is to be confined in the following...

Daniel Harding, colored, attempting to steal a drink of whiskey, four months in the county jail, commissioners privilege to hire out.

James Stanley, colored, larceny, five years. Appealed.

Tom McCotter, colored, larceny of logs, one year in the pen.

David Hines, colored, larceny. Judgment suspended on account of the youth of the defendant, and the clerk instructed to bind out.

Lemuel Hatch, manslaughter, 15 years in the penitentiary.

The trial of Jesse Dunston, col., who was arraigned on Monday for the murder of Joe Herring, col., is set for Friday.

Court adjourned to 9:30 o'clock this morning.

Ascension Day.

Today is the feast of the Ascension by the church calendar—forty days after Easter—in which is celebrated the crowning act of our Lord's mission on earth.

The account of this important event is but lightly dwelt upon by the Evangelists in the gospels. St. Matthew recites the commission given to the Apostles, but nothing of the Ascension. And St. John says "and there are also many other things which Jesus did which, if they should be written, every one I suppose that even the world itself could not contain the books that should be written, but does not speak of this event."

St. Mark and St. Luke both record the fact more or less clearly. The latter tells us that "And He led them out as far as to Bethany, and He lifted up His hands and blessed them. And it came to pass, while He blessed them He was parted from them, and carried up into Heaven." And the former who is noted for particulars in describing an occurrence, says: "So then after the Lord had spoken unto them, He was received up into Heaven, and sat on the right hand of God."

The event, however, is beautifully set forth in the Acts of the Apostles—generally accorded to St. Luke—and no speculation is left for the reader as to the fact. The circumstances all being clearly explained and the presence of the Angelic witnesses for the first time alluded to in connection therewith.

The Ascension has been correctly placed in the creed as the last act of God, the Son, in which we believe—that is acts of the past—and we then profess our belief in the present and the future. That He sitteth on the right hand of the Father; and that He shall come again to judge both the quick and the dead whose kingdom shall have no end.

The feast is one of universal observance in the Greek, English and Roman churches as well as the Catholic and Episcopal churches in this country, and will be of unusual observance in this country today by reason of its conjunction with the national decoration holiday.
