CULTIVATION OF LAND.

When our riding in few days ago, we noticed corn that in our opinion had been badly damaged by plowing.

At this time the grass is very large in the crops and the temptation is very great to plow deep and dig it up by the roots.

We have no doubt that deep plowing is the thing to be done in the early stage of the crops, but after the lateral roots have been formed it is absolutely ruinous.

Some of our farmers have not yet planted their corn that is to follow other crops. We suggest to them that a fresh coating of manure would be highly beneficial.

The plowing now should be especially deep and the furrows made to cut into each other so as to enable the land to retain moisture.
