He was proud of that and of the exhibitors, but he asked them to cultivate and raise good crops, yet you look in the departments where they ought to be, representative of the fair, and there are the horses, cows, sheep, and swine were grazing on the hills at home. Neither are the owners here to see what we are doing.

The colored people have merchants, large ones—and they had been notified that space would be given them to make displays, but with the exception of the merchant tailor, (Richard Sawyer), the rest of them are out of the fair.

He said on 24th. "We have had a great encouragement we ought to have had from the white people. For their fair filled with colored people, they may white people are here. They are resources as a source of glory."

"The city of New Bern has allowed the chairman of the committee to convert that sacred ground into a valuable place to sell whiskey to send to his sons to hell. Instead of saying to the world these are good colored people they are thus saying the opposite and they have sold space there for slanders to be set up in opposition to the fair."

"We are loyal to the city government, but they, in order that the fair should receive the greatest amount of compensation, have been allowing people inside the fair ground and they are now charging them the same as outsiders. This is a strike at this effort of ours in a few days before."

"I make these complaints respectfully and without abuse. They may come to us and we will rise again. They never will be able to do us, their wishes to the contrary notwithstanding."
