



A new phase of the Nelms case developed when Nelms produced a letter dated August 20, at Eugene, Oreg., surporting to having been written by Victor E. Innes to a physician of the ame city, in which he said

"Can you write me a strong letter showing that I am in a weakened condition and a physical wreck, and toill to travel?"

Nelms said that the police of San Francisco have compared the signature that was signed to the letter with the writing of Innes, and that there is a strong similarity between the two, and that, in consequence, he believes that Innes wrote the letter and signed his name to it. Nelms said that he reeived a telegram from his mother to-lay, saying that there had, been ad. litional evidence developed here.
