Wadesboro, Dec. 1.-J. A. Dunlap of Cedar Hill, a prominent citizen of this county, was instantly killed at 50'clock this alternoon by a through freight on the Seaboard Air Line. The accident occurred at the crossing on the Ansonville road immediately in front of the furniture factory.

The buggy in which Mr. Dunlap was riding was demolised but horse he was driving was uninjured. The train was a fast freight soutbound and the cure at the crossing makes it extra dangerous for these driving on the road. Mr. Dunlap drove on the track immediately in front of the train and the engine stuck the buggy. Death was instanteneous, caused by a blow on the skull.
