

# **Committee Praises Board Of Education**

The newly appointed School Improvement Committee of Rose Hill Elementary School No. 1 in a letter to Russell Brock, Chairman of the Duplin County Board of Education, pr-aised the board for the speed with which the substitute facilities were readied for the use of the pupils.

The committee noted that there were still several improvements that must be made to ready the present building for. the two years it will be used before the new building will be ready for use. '

The following needs were cited by the committee:

(1) One additional mobile classroom is needed to remove a fifth grade from an undesiralbe classroom in the cafeteria building. This will allow an entire grade to eat at one time.

This is necessary because the school is now using the block teaching system and the pupils

(2) A lavatory is needed in each classroom for sanitation purposes, as well as to faciliate the teaching of art and other related activities. At present there are only two lavatories for more than 400 pupils.

(3) It is suggested that the bathrooms at the rear of the white wooden building be reactivated as there are only 8 commodes to accommodate all the pupils.

(4) In the interest of safety the fence should be restored on the highway and extended 20 feet north down the private road. (5) Boardwalks are needed to connect the school facilities because of flooding conditions after an average rain.
