Governor Jim Hunt, Senator Harold Hardison. and Representative Douglas Clark. Keith Oates of the state land drainage program, and David Under-hill, of the county landfill, requested the letters saying the program is in danger of being genlaged with a loss being replaced with a less effective method of mosquito control.
