What Cooperation Means.

Farmers in Limestone Co. Alabama, built up a fine hograising industry, but they were far from any central mals to professional buyers. The returns to the farmers were very disappointing. A Better Farming Association was organized and their hogs marketed cooperatively and on twenty car loads sold in this way received four cents a pound more than offered by local buyers. The saving in one year was around \$12,000,

Farmers around Orchard, Nebraska, organized a cooperative association and marketed \$147,850 worth of their products. When they assembled in Orchard a short time ago one of the local merchants furnished an orchestra for their entertainment. His trade had increased fourfold since the cooperative association began operations, he said. The town had become a popular Helen E. Turner, of Freeport, trading point with farmers Long Island. Such practices led to the organization of the Southeastern Missouri Melon Growers' Association, which sells the farmers' products tions for work she anticipated cooperatively. Returns to the farmers have in many cases been increased to four or five times the amount received under the old method of selling to chance buyers.
