Section 9. That for the purpose of submitting this ordinance to the voters of the Town of Tryon an election is called for said purpose, to be held at the Town Hall in said Town of Tryon on Tuesday, the 22nd da y of November, 1921, and H. Doubleday is appointed as Registrar and R. T. McFee and A. L. Hill as Judges and poll holders at said election, and a new registration of the voters of said town is ordered.

Said election shall be held under the general provisions of Subchapter III entitled "Municipal Finance Act" of Chapter 56 of the Revised Statutes of North Carolina, entitled "Municipal Corporations."

I, W. W. Creasman, propose the adoption of the foregoing ordinance, this the 26th day of September, 1921.

The foregoing ordinance was passed on its third and final reading on the 28th day of September, 1921, and was first published on the 30th day of September, 1921,


