GRAND JURY SUBMITS ITS REPORT TO THE JUDGE

1. The County Home.—We visited the County Home and found two (2) males, two (2) females, and two (2) children, who say they are well cared for. We found a plenty of bacon, some corn, about 150 young chickens, 20 hens, 34 head of hogs of various ages and sizes which are all in good condition. The farm and farming implements are in good condition. They have a good garden and there were plenty of vegetables in the garden, good corn and potatoes.

2. The Stockade.—We found the Stockade in good sanitary condition and up-to-date in every respect.

3. The Jail.—We found the Jail in good condition and the prisoners were well fed.

4. The County Court House.—we visited all the offices in the Court House and found them well kept and in good condition.

"We found twenty-three (23) true bills, an one (1) untrue bill. We also made four (4) presentments.

"We recommend that the Court House be locked so that the lights will not be tampered with at night, and also that the toilets be repaired and put in good mechanical condition.

GEORGIA WAREHOUSEMEN OPPOSE FIXING OF FEED

South Georgia were ready to serve suit in United States district court at Macon tomorrow asking injunctions against enforcement of a State act regulating fees.

The petition, which is to be filed with Federal Judge Bag-

gott S. Deaver, claims Federal Court has jurisdiction in the matter under the 14th Amendment, contending the State law deprives petitioners of their business without due process of law.

Owners of warehouses or their employes may be prosecuted as for a misdemeanor if they violate the new tobacco law passed by the Legislature in March.

Maximum charges allowed are: Auction fees, 15 cents per 100 pounds and 25 cents for each additional pile of 100 pounds; weighing fees, 10 cents per 100 pounds; commissions, 2 1-2 per cent of gross sales.

Terming these fees confiscatory, warehousemen are asking injunctions against State, county and State court officials to prevent enforcement of the law.
