The burglary was first discover-ed Friday night by David Mans-field, of Mansfield, at the home of his brother-in-law, J. B. Askew, of New Bern. The cottage, at the west end of the beach, had been entered by forcing a window, and considerable damage had been done in forcing inside doors, which done in forcing inside doors, which had all been locked.

From the Askew cottage, sheriff's officers went to check on other cottages at the beach, and discovered that six had been entered. They were the property of Romaine Howard, Tarboro; Roma Clarence Grice, Wilson; Roger Gant, of Burlington; S. D. Woodard, believed to live in Golusboro; Dr. Lee, of Kinston, and another Mr. Gant, believed to be the brother of Roger Gant.

A heavy rain Friday obliterated any possible tracks, though officials said the thieves must have used a car or truck to carry off their loot. George Canady, of the their loot. George Canaoy, or the state bureau of investigation, went over the cottages for fingerprints, and sheriff's officers expect to fice. Mayor George W. Dill, former Raleigh clear up the case soon.
