

Newport Man Sentenced To Serve Six Months

A Newport man, Early Thomas Taylor, was sentenced to serve six months in jail Monday after he was convicted of careless and reckless driving in court action at Morehead City recorder's court. Taylor had originally been charged with drunk driving but the warrant was amended to read careless and reckless driving. Judge Herbert O. Phillips III suspended the jail sentence on the condition that Taylor surrender his driver's license for 45 days and pay a fine of \$100 and court costs.

In other court action, S. A. Turnage appeared before the court charged with drunk driving. After pleading not guilty she was found guilty as charged by the court. Her 90-day jail sentence was suspended on the condition that she pay a fine of \$100 and court costs. The defendant noted an appeal to the next term of superior court and

bond for her appearance was set at \$150. The state decided not to prosecute Mrs. Mary Jane McGonigle of Hubert, N. C., and John F. Cox of Morehead City. Both defendants were charged with issuing bad checks.

Also not prosecuted were Dominicus A. G. DeJong of Rotterdam, Holland, and Paulus Hessing of U. Trecht, Holland, charged with public drunkenness.

Clarence D. Whitehurst of Beaufort was acquitted on charges of attempting to break into and enter a residence at 403 Arendell and forcible trespass.

In traffic cases James Lee Johnson of Atlantic Beach was ordered to pay court costs for speeding and Charles Brooks of Beaufort paid court costs for failing to stop for a stop sign.

Two break-in cases were ruled malicious prosecution by the court when the prosecuting witnesses dropped charges against defendants Eddie Lee Watkins and Edward Henderson, both of Morehead City. Watkins had been charged with breaking into the residence of Roberta Gibson and the prosecuting witness in the Henderson case was Beatrice Mitchell of 1300 Fisher St.

The trespassing case against Paris Willis of Morehead City was not prosecuted.

Judge Phillips continued 14 cases until next week's term of court. The original settlement at St. Paul, Minn., was called Inniskilla. It became St. Paul in 1841.

Joe Baum - Possession of non-taxpaid whiskey. Sixty days in jail and roadwork suspended on payment of \$50 and costs.

Carlton Pittman - Public drunkenness. 30 days in jail and roadwork.

Guy Lewis - Violation of fishing laws. Not prosecuted.

Seventy-eight cases were continued until later terms of court.

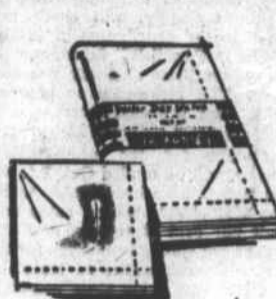

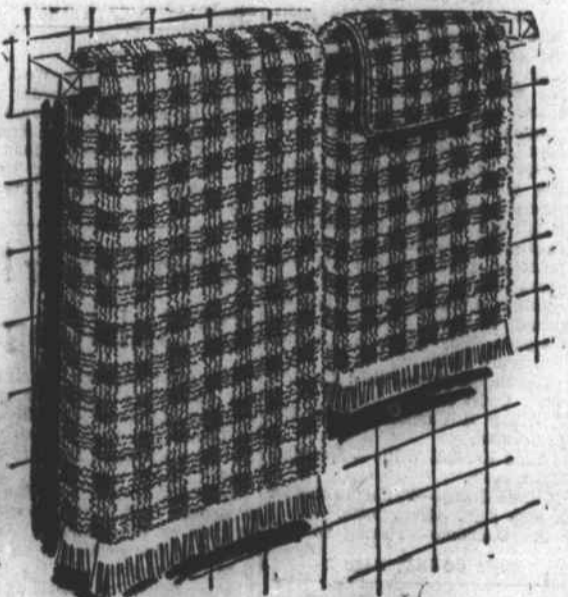

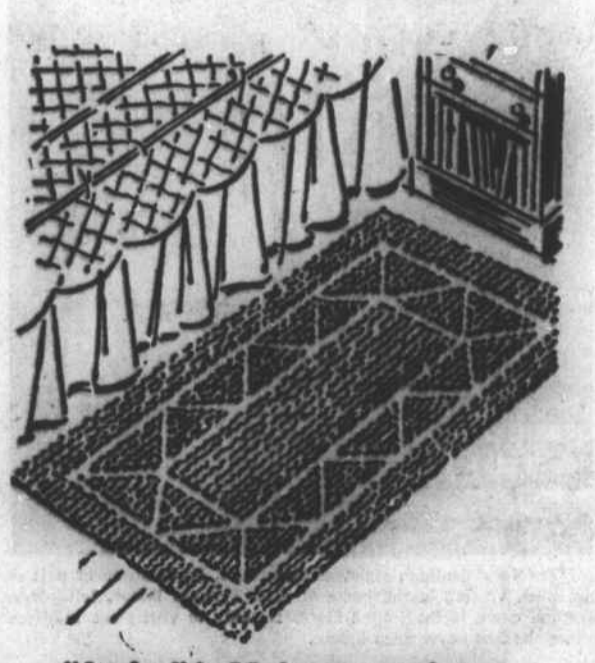
